Murton Post Office is well established, the current owners have been in situ since 2002, this is a 'mains' Post Office which also offers passport & driving licence services. The closure of a local bank has encouraged local businesses and customers to the branch. There is an external ATM machine which forms part of the Post Office services.

Location

The Post Office is situated in the heart of the town, close to other local independent businesses. Murton is close to the A19, Dalton Park and surrounded by residential properties, with new housing developments being built. The store benefits from being on the bus route and close to the community & medical centre offering lots of passing trade.

Internal Details

The trading area has one till and to the rear a secure mains post office counter, greeting cards gantry, upright drinks chiller, stationery display, a small selection of crafts and sowing, Lottery terminal and scratch cards . Our client has chosen not to introduce convenience, confectionary or alcohol. This is something a new owner may wish to consider subject to the necessary permissions required.

There is also an inner office, stock room and staff toilet.


The Opportunity

Our client has successfully operated the business since 2002 and now wishes to retire. This would certainly suit a purchaser looking to work for themselves for the first time, having the benefit of steady trade and located in a busy area.

We feel there is scope to increase the stock product range, with the necessary permissions required adding alcohol, convenience, confectionary, joining a symbol group, extending the currently limited trading hours and reconfiguring the retail trading area could also increase sales.

Trading Information

The Post Office annual commission is c. £52,000 and shop sales around c. £25,000 per annum with the sale of cards, cold drinks, craft & stationary items. There is scope to improve the sales figures by adding further sales lines including applying for an alcohol licence and joining a symbol group.


