



LOCATION COMMENT

Piddington is a small village very close to Oxfordshire's border with Buckinghamshire with an active and friendly local community, active village hall and church. The popular Bull and Butcher Pub can be found in nearby Ludgershall, and the Michelin star Nut Tree Inn at Murcott. 9 miles from Oxford, on the Headington side, with access to excellent schools and hospitals. Bicester is 4.5 miles away and conveniently has two train stations. Bicester North offers a great commuter service to London Marylebone in around 45 minutes, and you can reach Birmingham in 1 hour. Bicester Village train station offers service to Oxford and to Nearby London Marylebone.
