The market town of Beverley is located in the East Riding of Yorkshire. It is approximately 8 miles north west of Kingston Upon Hull and some 26 miles to the south east of York. The town also benefits from an estimated population of 30,927 (census 2021).

The property is located on North Bar Within which is at the northern end of the principal shopping area close to the prime areas of Saturday Market and Toll Gavel. Market Place is adjacent which provides some of the most central car parking in the town. Surrounding occupiers include Mowgli Indian Restaurant, Pizza Express, Barbour Fashions and numerous independent retailers, restaurants and bars.

### Description

The premises comprise a 3 storey grade II listed building. The ground floor is currently used as a banking hall with associated back of house area. At first floor level there are a number of offices, staff areas and a board room. The second floor is laid out as a series of rooms but is not currently in use.

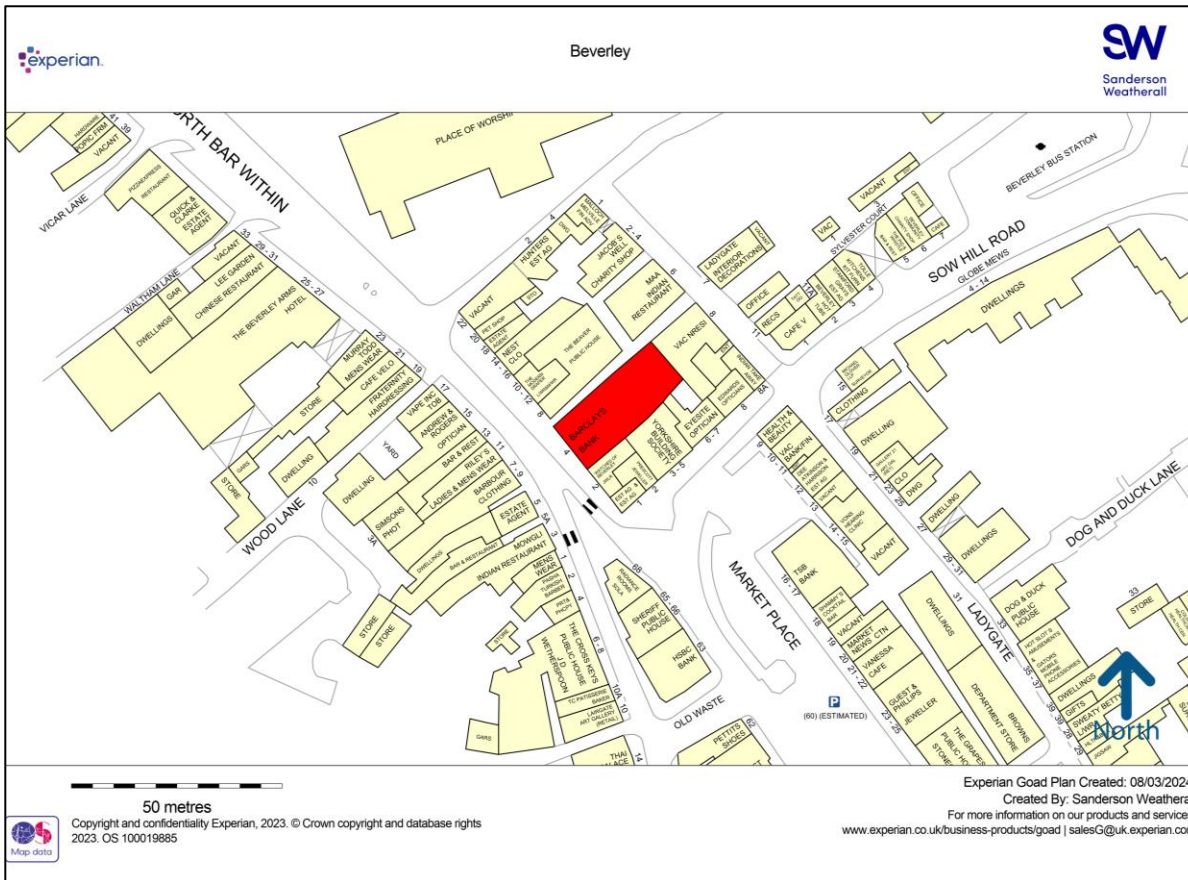
