The buildings that comprise the Roundhouse Business Park are like no other.

Dating back to the mid 1800's they formed part of a busy depot for the repair and maintenance of locomotives serving the Leeds and Thirsk Railway. The site was still in use as a train depot up until the early 1900's. Today the two existing roundhouses and canalside buildings have Grade II listed status. No comparable group of railway buildings still exists in the country.

The buildings have been sympathetically restored to provide working environments of great character.

Many of the period features have been retained and blend in with the modern refurbishment to provide open plan offices with good natural light and ample on-site parking.



The Roundhouse Business Park is situated fronting the A58(M) inner ring road, which in turn provides access to junction 2 of the M621 and the region's motorway network and beyond.

The property is within easy reach of the city centre and Leeds railway station and walking distance from all of the city amenities.
