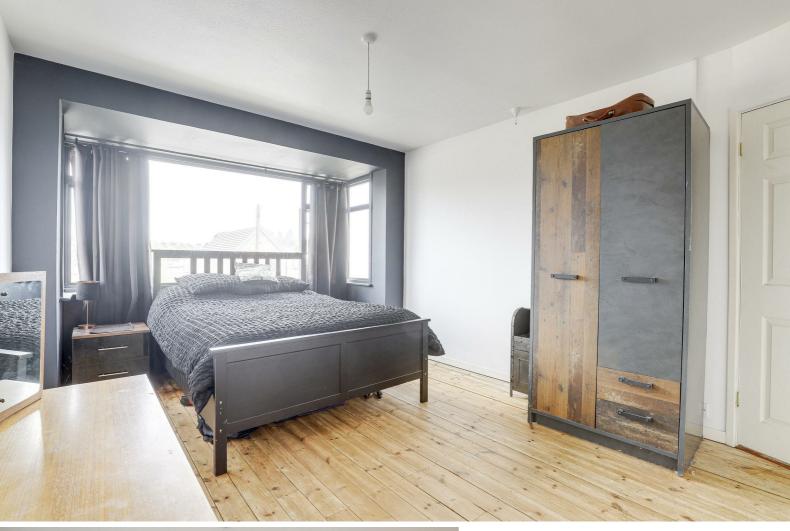

Externally, the front of the property offers a driveway providing off-street parking and access to the garage, as well as a lawn with a hedge, and gated access to the private enclosed rear garden with a paved patio seating area and a lawn.

Entrance Hall

 12^4 " × 3^1 0" (3.78m × 1.18m)

The entrance hall has carpeted flooring and stairs, a radiator, a double-glazed window to the side elevation, and a single UPVC door providing access into the accommodation.

Lounge/Dining Room

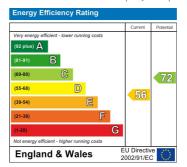

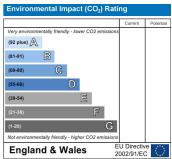

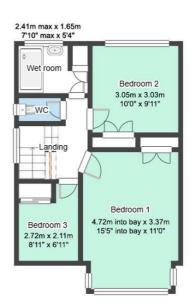
