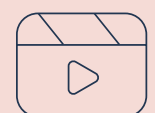

The building is also within close proximity to Regent Street with a rich variety of restaurant, bars and retailers.



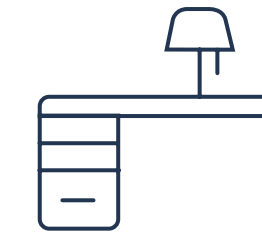

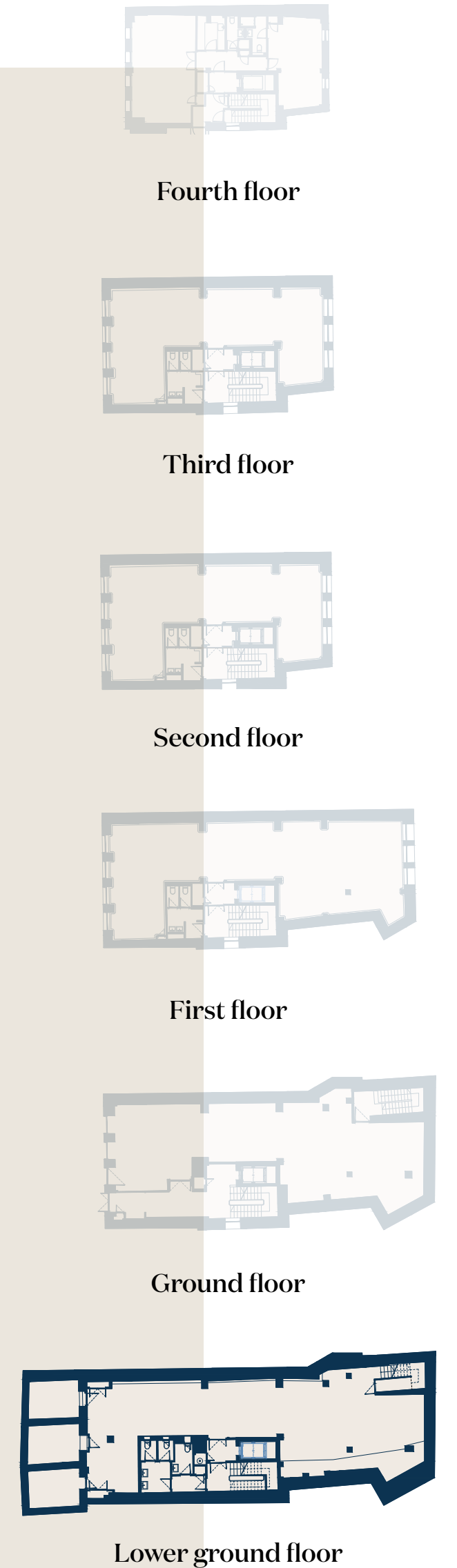

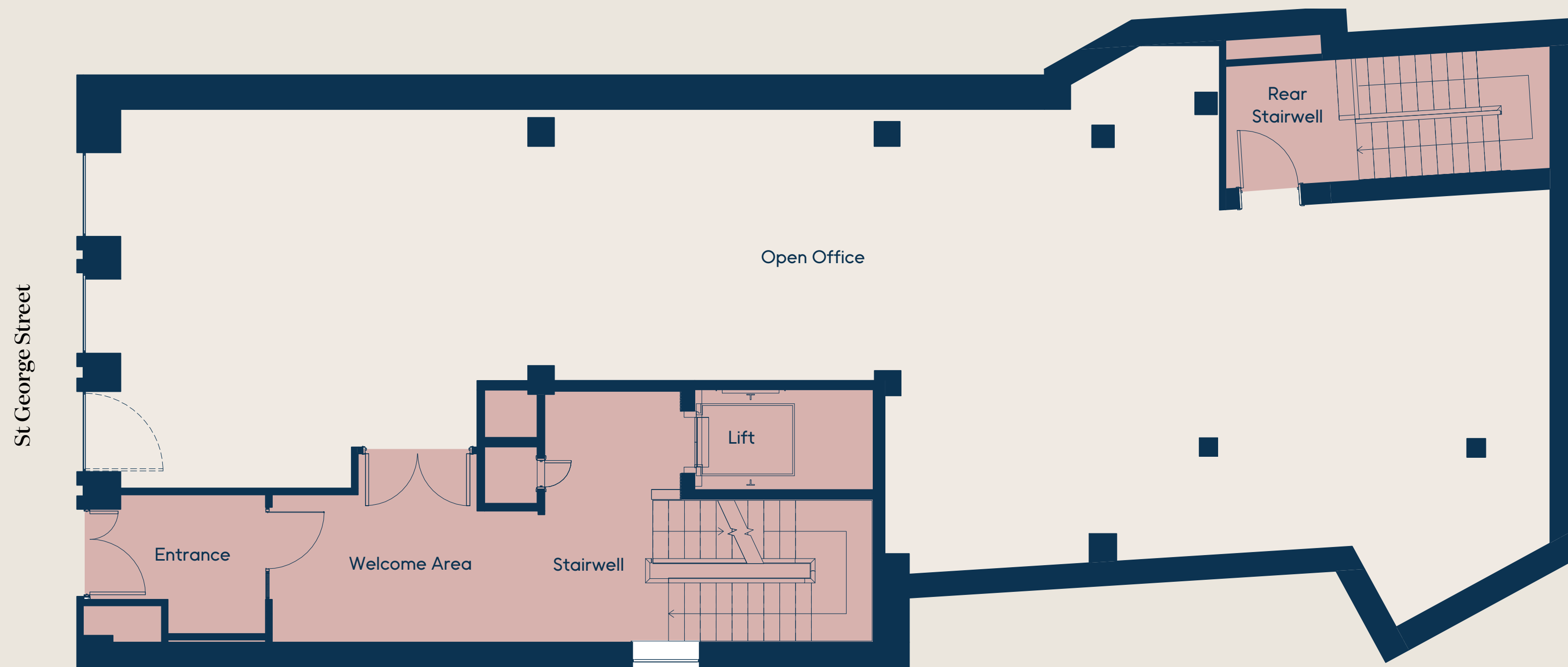

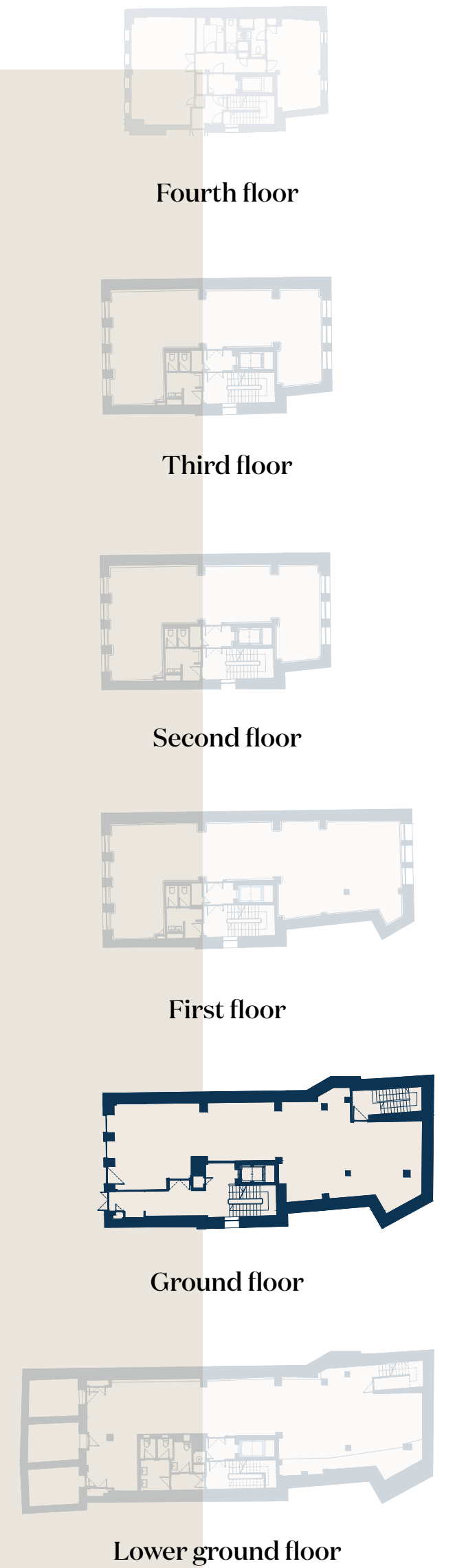

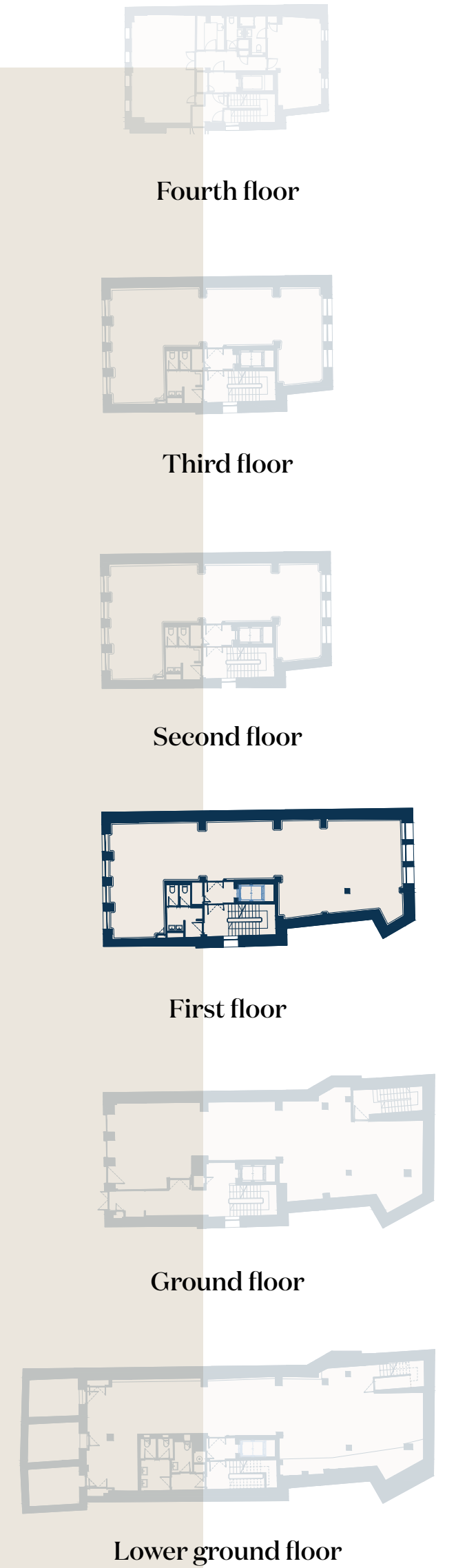

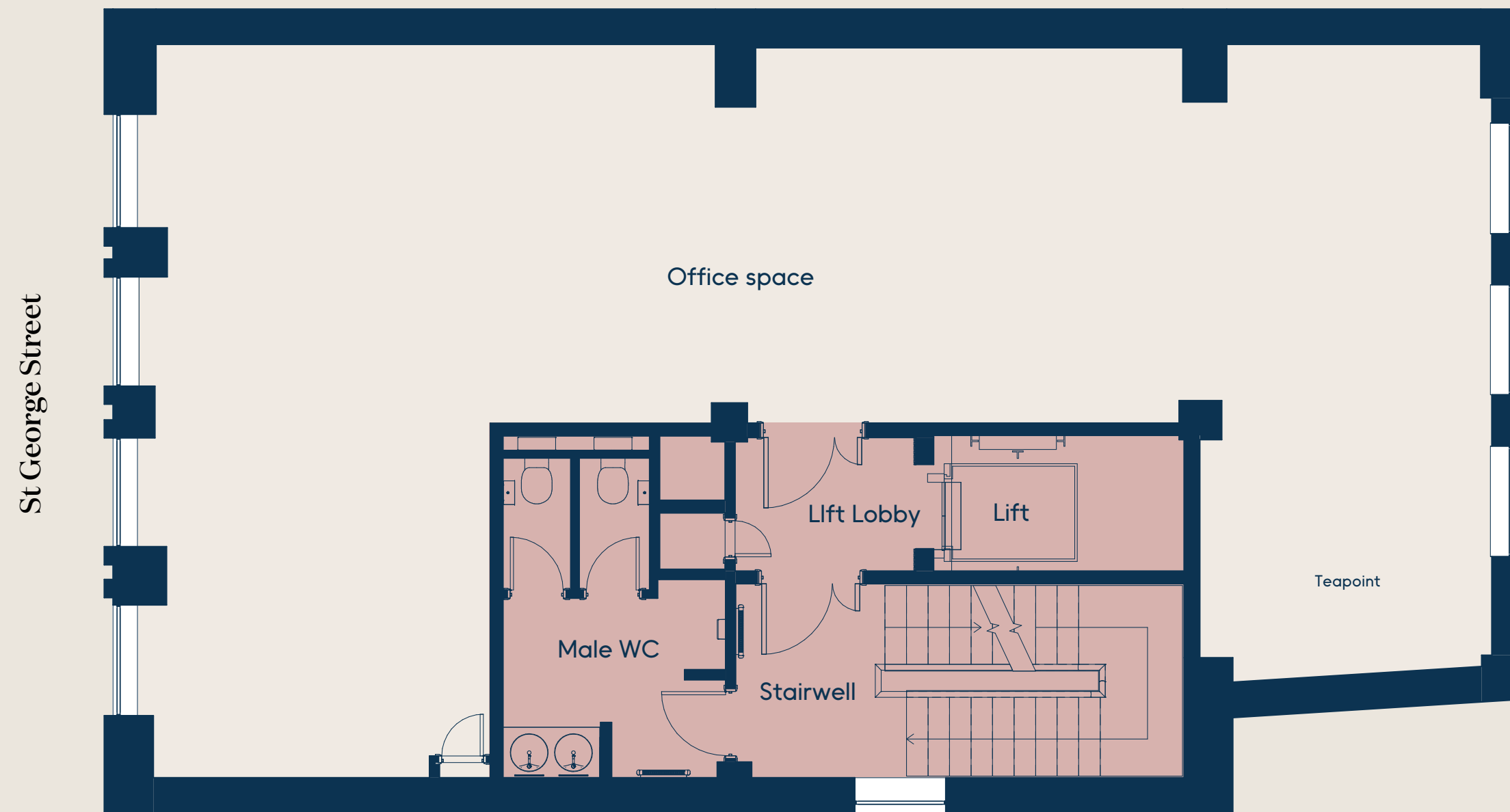

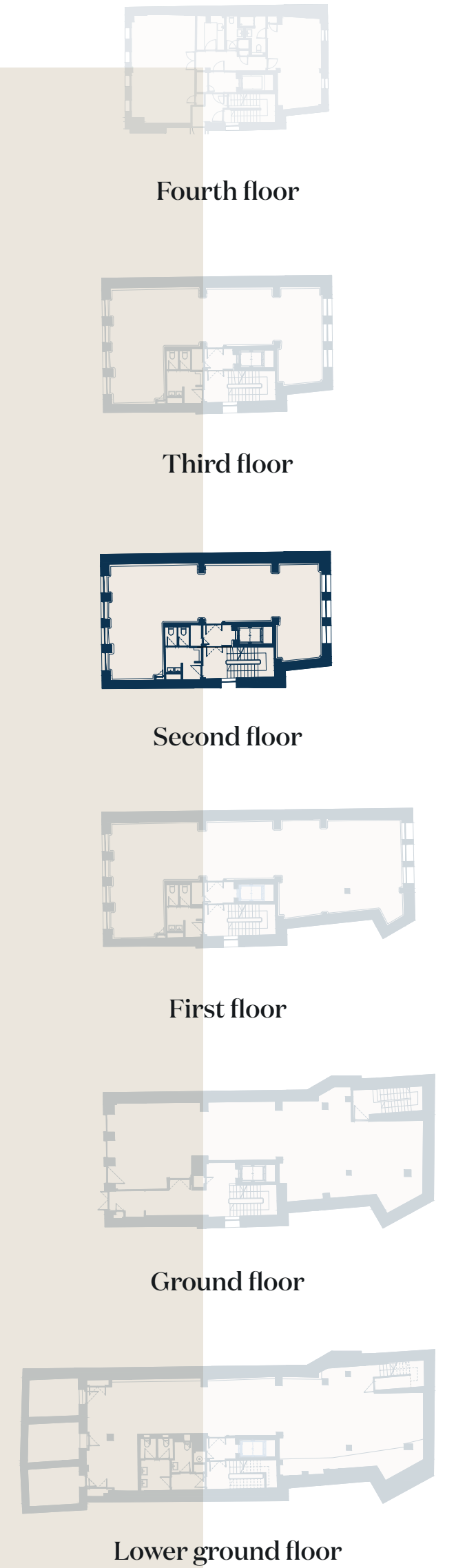

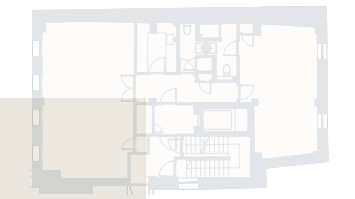

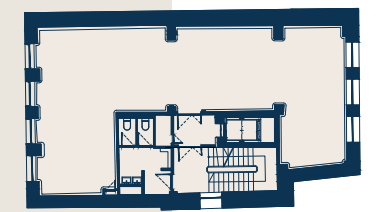

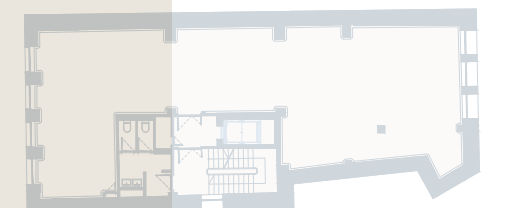

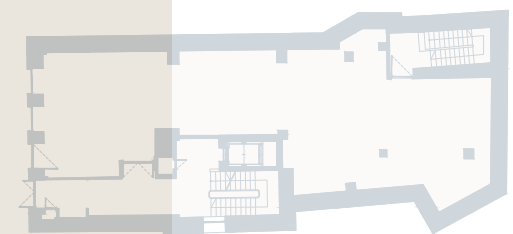
