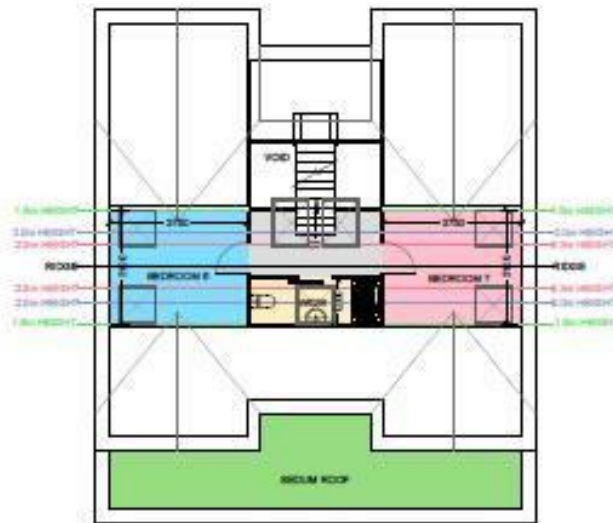

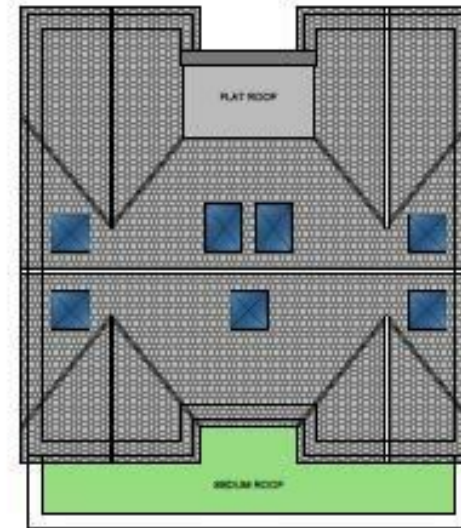
PLOT 1 LOFT FLOOR PLAN

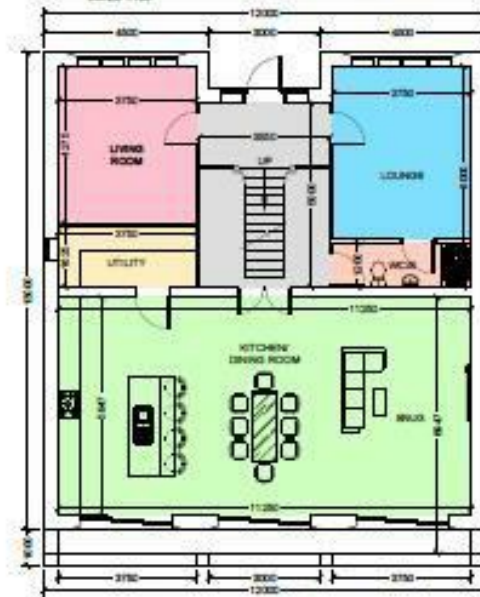
PLOT 1 ROOF PLAN

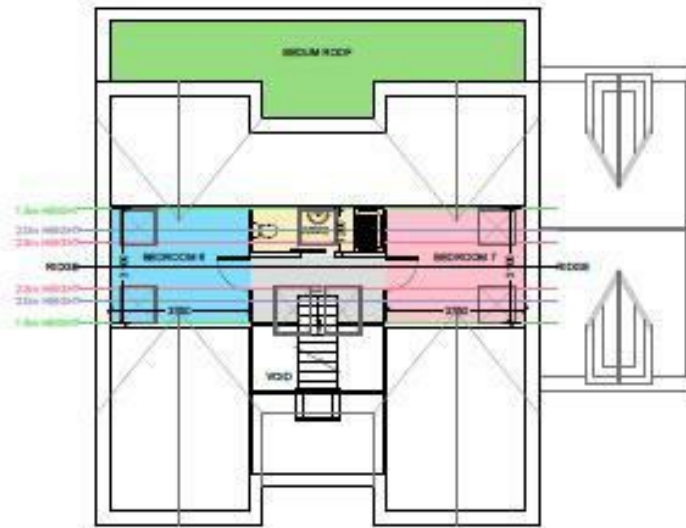
PLOT 1 FIRST FLOOR PLAN

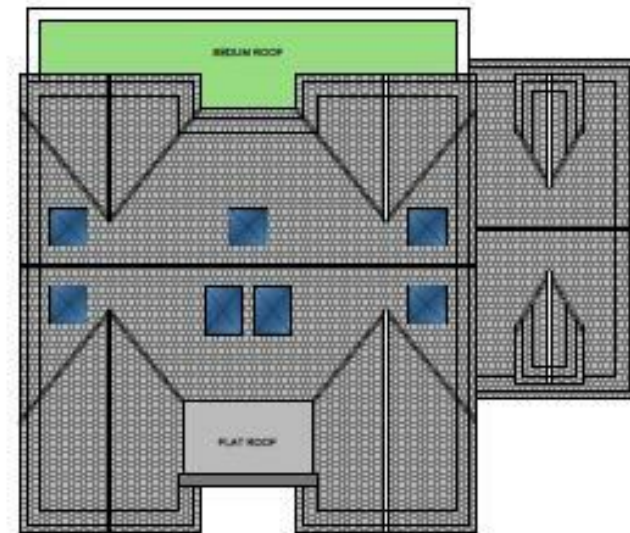
PLOT 1 BLOCK PLANS (SCALE 1:100)





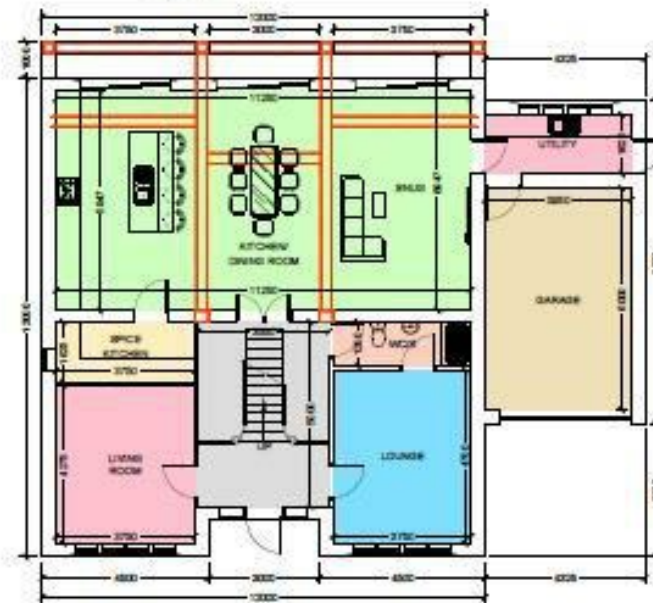
PLOT 2 LOFT FLOOR PLAN

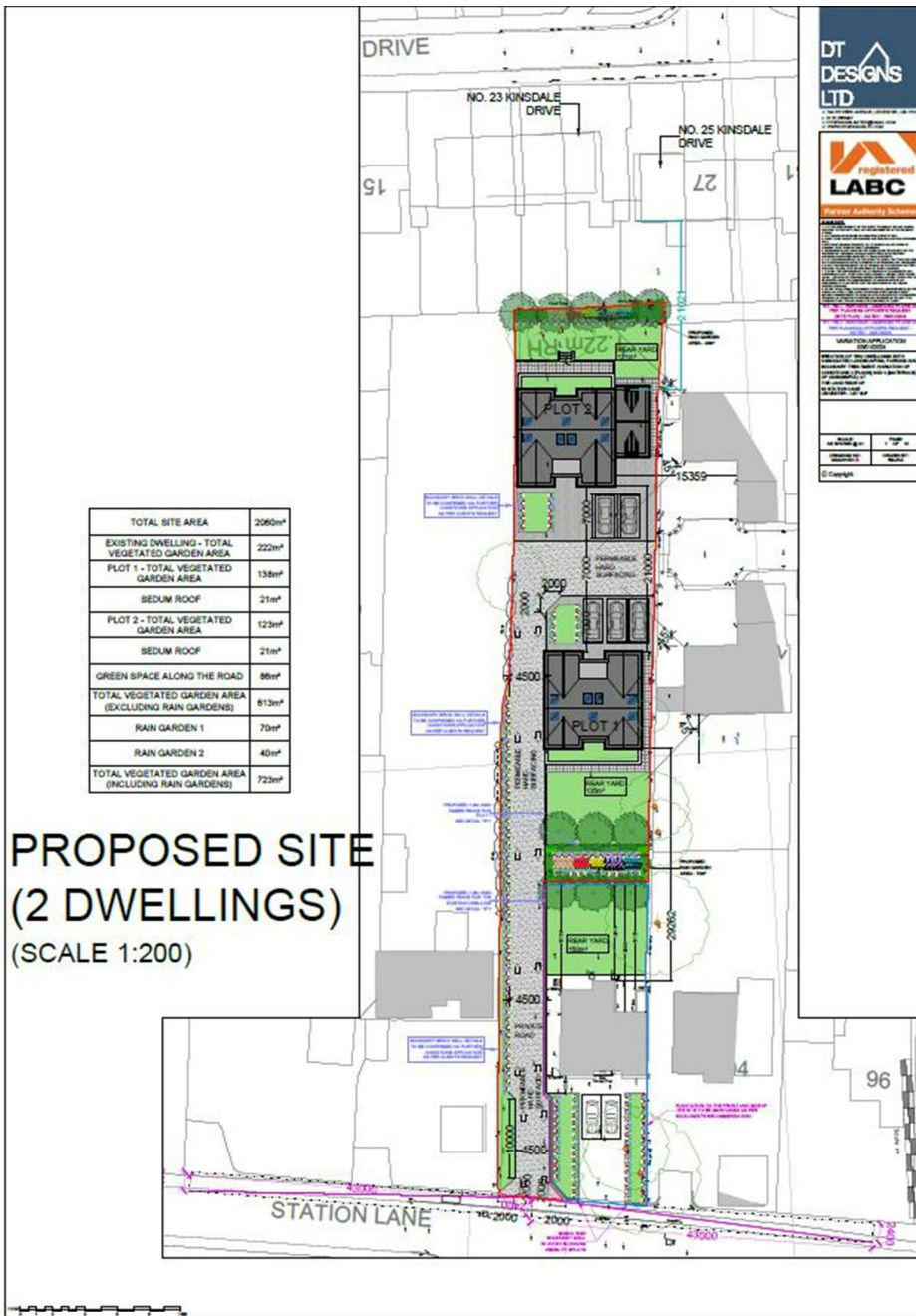


PLOT 2 FIRST FLOOR PLAN
