Property Description

Location

Willington Old School is located on The Castle Way in the village of Willington located to the south of Derby.

Description

The Former School site totals 0.39 acres (1,347m²) or thereabouts, comprising a substantial single-story purpose-built Victorian school building, built in 1894 with a post war Horsa Hut and a two bedroom school house (with a garden to the side). The main block is of brick construction under a pitched tile roof, Horsa Hut is a prefabricated concrete building under a assumed asbestos roof. The total gross Internal (GIA) area is approximately 361m² (3885 ft²) and is further described below.

All main services are connected and the property benefits from gas fired central heating.

Floor Plans

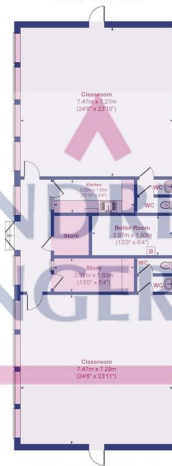

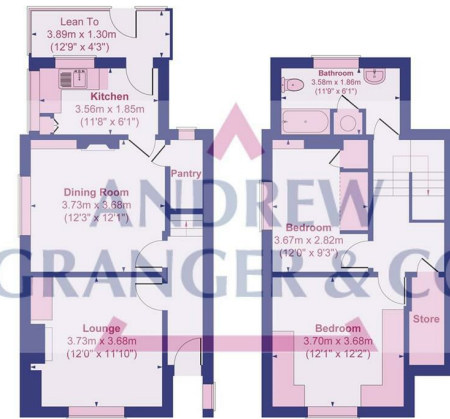


Floor area 191.9 sq.m. (2085 sq.ft.) approx
