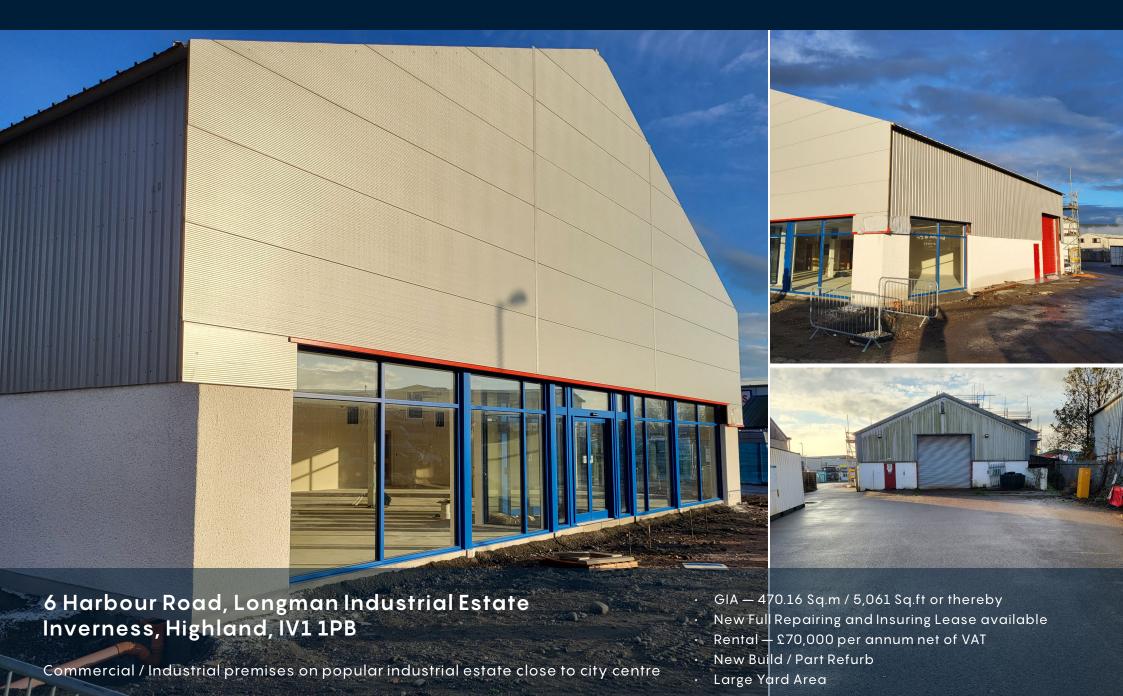
TO LET SHOWROOM / COMMERCIAL / INDUSTRIAL





LOCATION

The property is situated on Harbour Road which is the main thoroughfare on the Longman Industrial Estate. This is the main business / industrial location and the premises are well situated to access the trunk road network. Nearby businesses are mixed having both national and local firms in the area.

DESCRIPTION

The property comprises a showroom (potentially suitable for office use) and warehouse. The front showroom area is new build and the rear warehouse is refurbished space. The final site works are still to be completed but it is understood there will be parking at the front of the property.

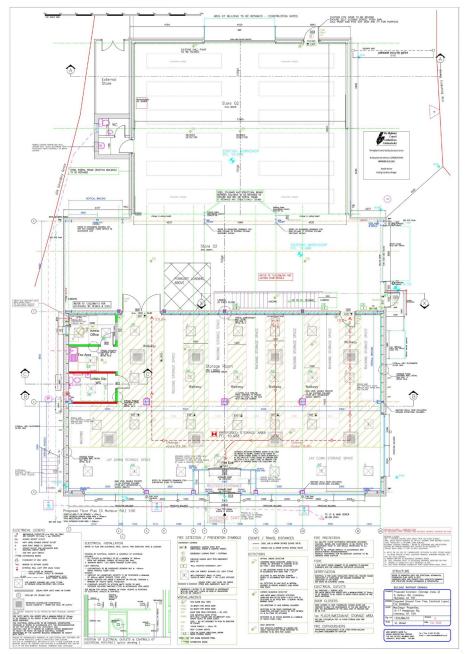

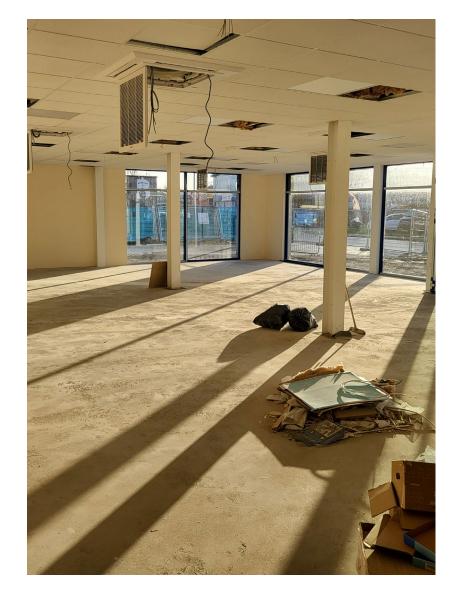

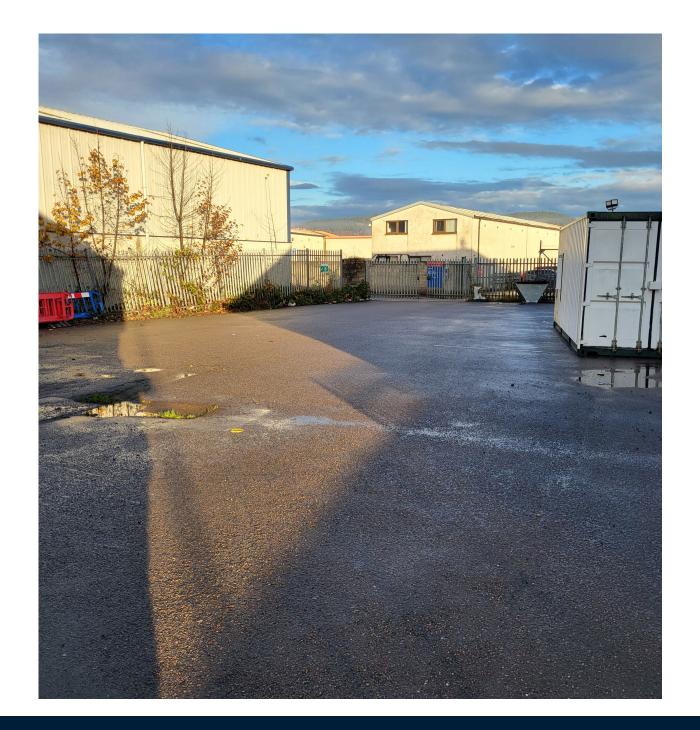
We are unaware of any service charge arrangement. There is a common access which is assumed to be private at the rear of the property.
