From the entrance hall, you will find two double bedrooms to the front aspect of the property. There are also two reception areas, comprising a comfortable lounge with AGA dual fuel burner and to the rear a particular feature of the property is the expansive conservatory to the rear. Double doors open up to the generously sized southerly aspect rear garden, which offers a good degree of privacy and seclusion. The kitchen and bathroom complete the accommodation. Heating is provided by recently updated electric night storage heaters, as well as the dual fuel burner.

The detached garage to the rear of the plot provides useful additional storage. Vehicular access is not currently in use but can be easily reinstated from the lane running to the rear of the bungalow. The garage also has power and lights. To the front of the property is a driveway providing off road parking, plus there is an area of easy maintenance front garden.

The bungalow is conveniently situated close to shops, facilities and transport links and is offered for sale with vacant possession and no forward chain. An ideal opportunity to create your perfect home awaits.

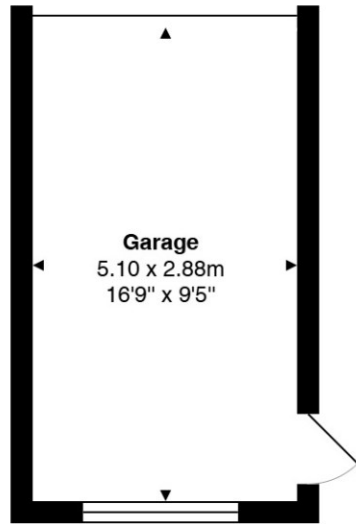

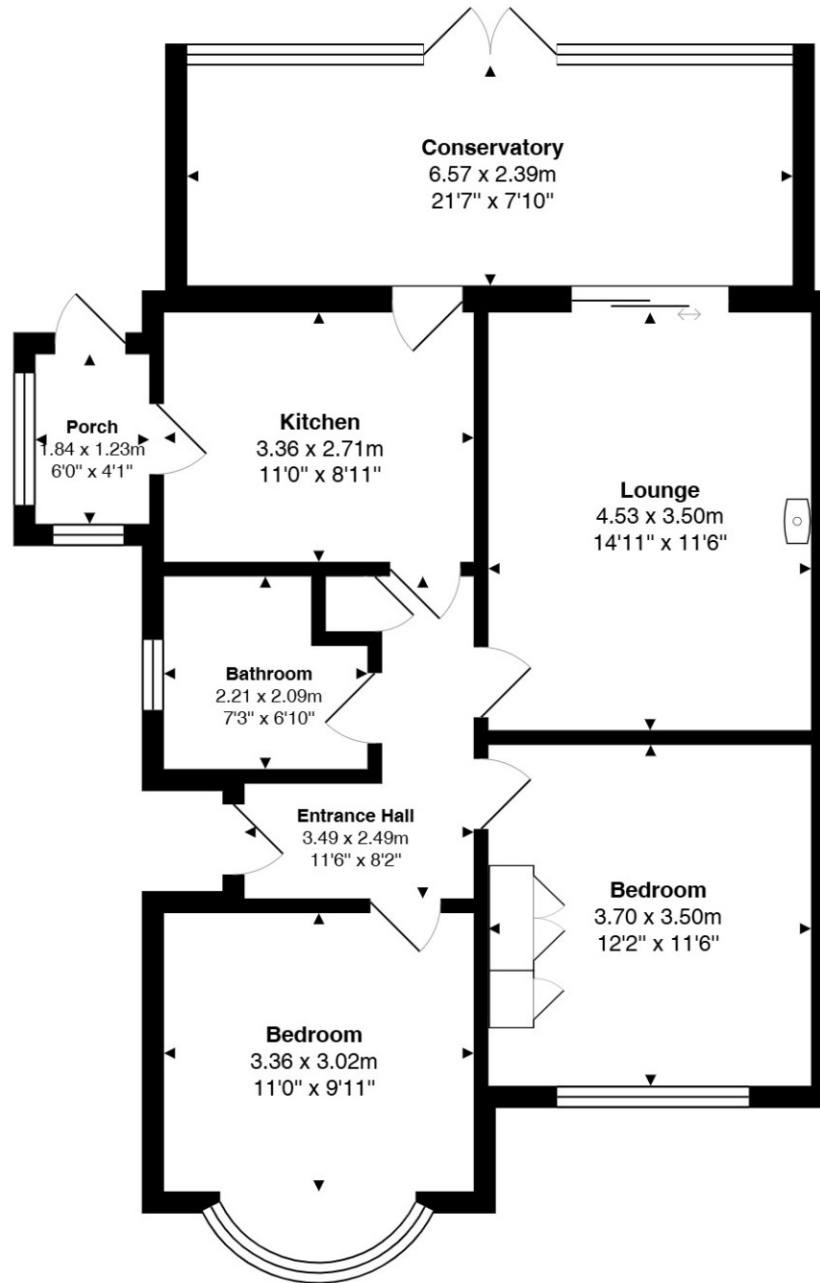


FLOORPLAN
