DESCRIPTION

An end-terrace light industrial/warehouse building in an established business park close to the A38 Devon expressway.

The premises comprise a modern, steel portal frame building with brick and block elevations, externally rendered and insulated with plastisol steel clad roofing, facing brick panels.

The unit benefits from a warehouse area accessed by a roller shutter door and separate pedestrian access, together with w.c. facilities. There are stairs to the first floor which has been laid out as high quality offices.
