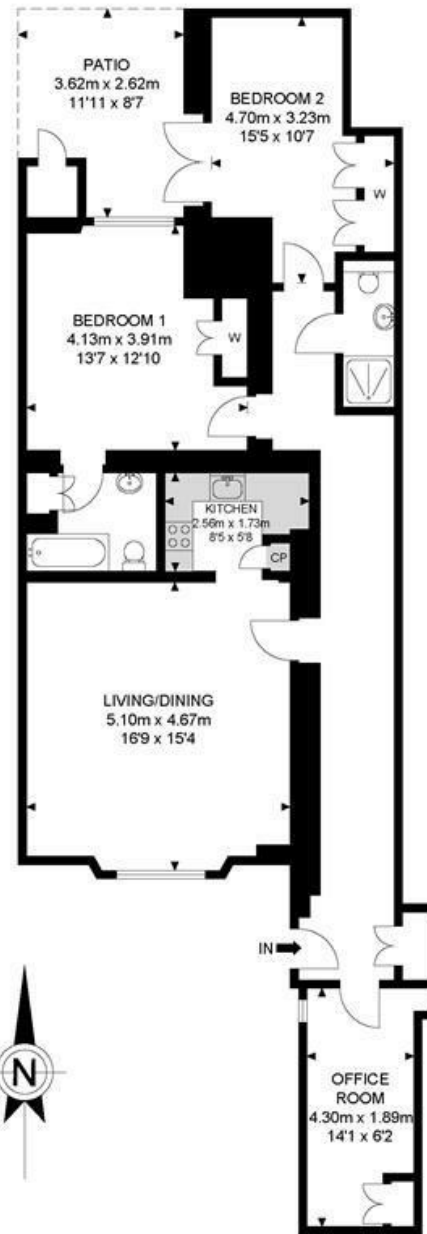


Queen's Gate Terrace

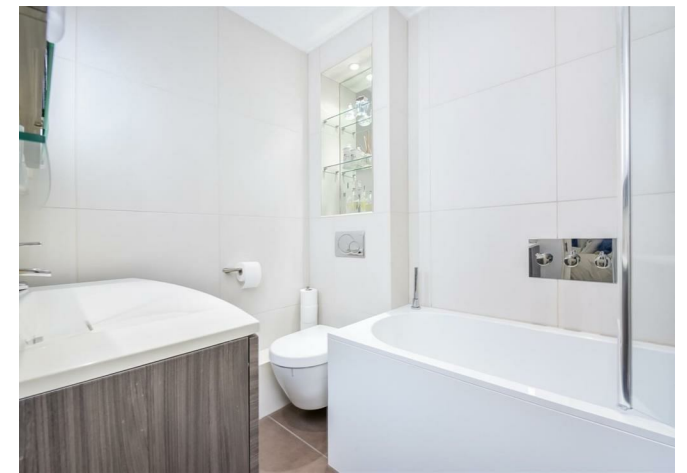
