Description

The Arc has been thoughtfully designed by AHMM and will provide 150,000 sq ft of top specification offices, together with retail and residential. The offices will be accessible via two prominent dedicated office entrances on City Road and Shepherdess Walk. The office accommodation occupies Levels 1 to 6 with typical floorplates of 20,000 – 26,000 sq ft and private terraces on Level 5 and a communal terrace on Level 7. Scheduled to complete in Q4 2023.

Location

The Arc occupies a prominent location at the intersection of City Road and Shepherdess Walk, the building is within 500m of Old Street station which is located to south east of the Site. The Bower, The Atlas Building, M by Motcalm Hotel, Eagle House, 250 City Road, Lexicon and Canaletto buildings have all recently completed to introduce new residential and commercial space on City Road. The world renowned Moorfields Eye Hospital is located directly opposite. The area around Old Street Roundabout is known as 'Silicon Roundabout' due to the abundance of technology companies who lead the UK technology industry.

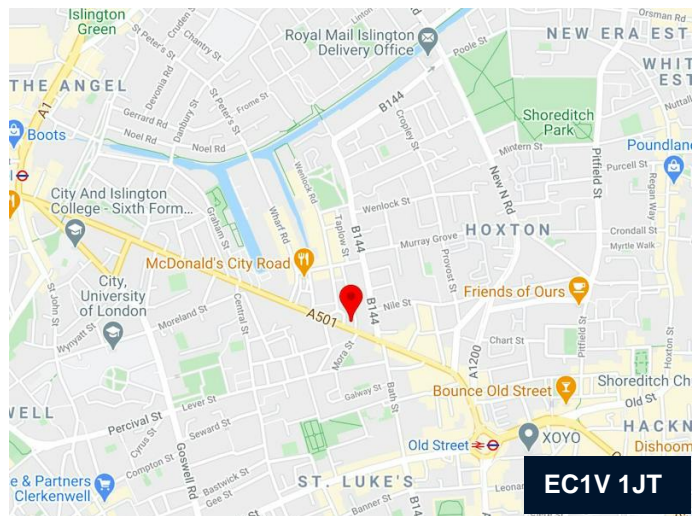
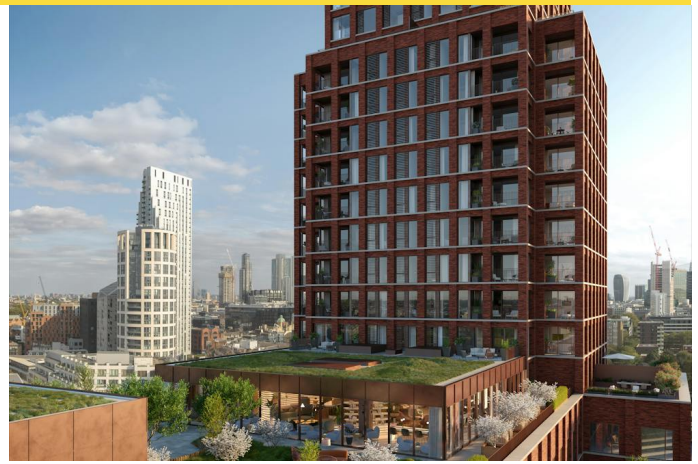
