Benefitting from a dual entrance, 77 Chancery Lane provides 16,503 sq ft across LG - 3rd floor. The lower ground provides bike storage, showers, lockers and conference/meeting rooms.

The building has low energy LED lights with daylight dimming sensors and solar glazing to prevent solar gain. 77 Chancery Lane benefits from reclaim ventilation with air source heat pumps to maintain optimal temperatures and reduce environmental impact.

Location

77 Chancery Lane is perfectly located between The Royal Courts of Justice (3 mins), The Rolls Building (3 mins), Gray's Inn (5 mins) and Inner and Middle Temple Inns (7 mins). The newly refurbished building is within 5 minutes walk to Chancery Lane and Holborn tube stations, and within 10 minutes walk to Farringdon, providing direct access to Thameslink, Elizabeth, Central, Piccadilly, District, Circle and Metropolitan line.

Historical pubs can be found among fine dining options such as the Holborn Dining Room, or try cocktails at Baranis. Wildy & Sons' bookshop is just round the corner from 77 Chancery Lane for legal titles and antiquarian books.
