## Location

Cheshunt is in the Broxbourne district of Hertfordshire with a population of approximately 50,000 people. The town offers good transport links southbound via the A10 to the M25 and London, or the northbound access to the M11 and A1.

## Property

The property is situated on the New River Trading Estate located in a highly prominent trading position adjacent Brookfield Retail Park and Tesco Extra. The industrial estate is due to be demolished in 2025 to facilitate the new Brookfield Riverside development meaning tenancies will be short term.
