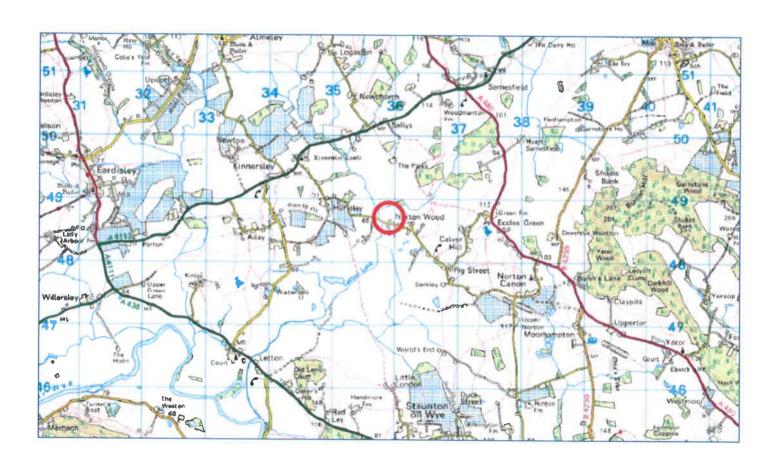

The whole extends to some 13.33 Acres.

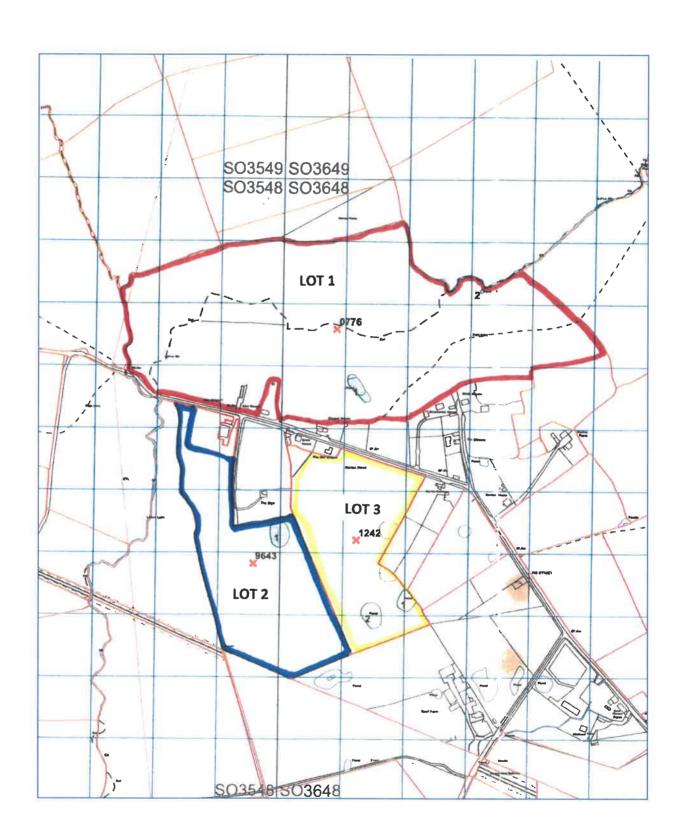
