Location

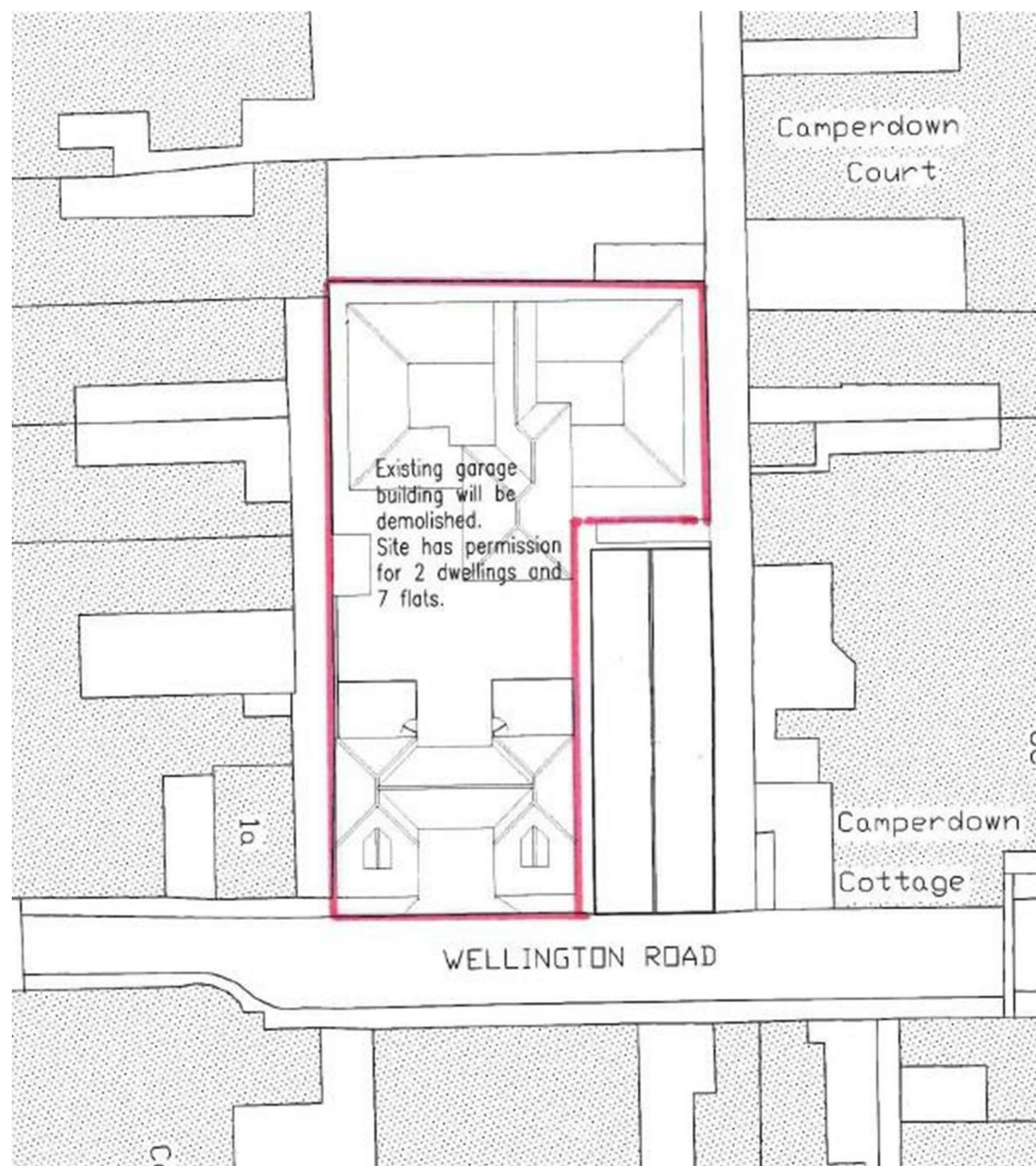

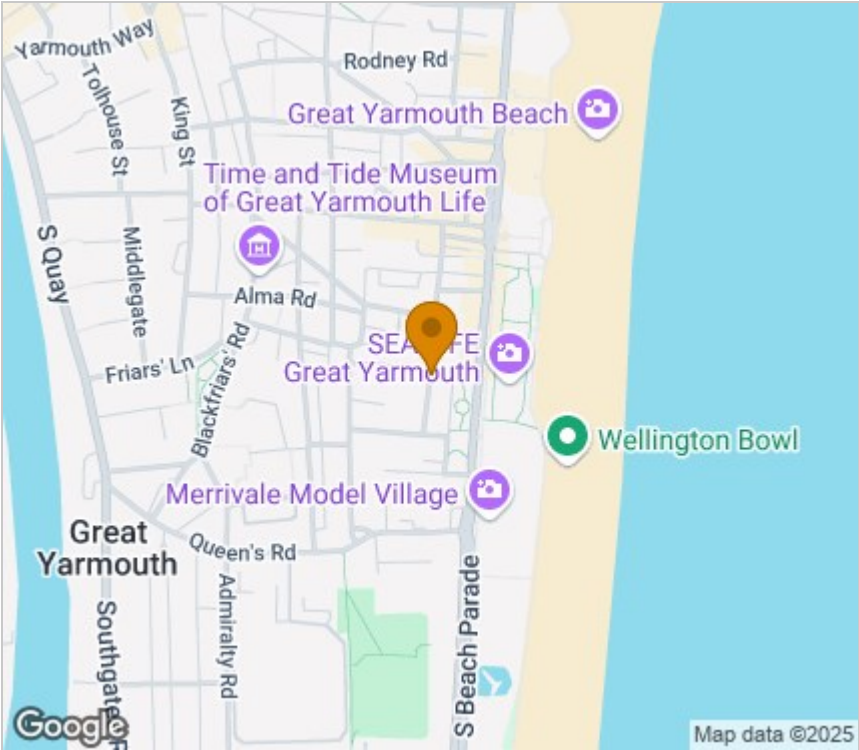




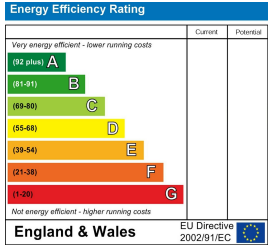
Floor Plan
