



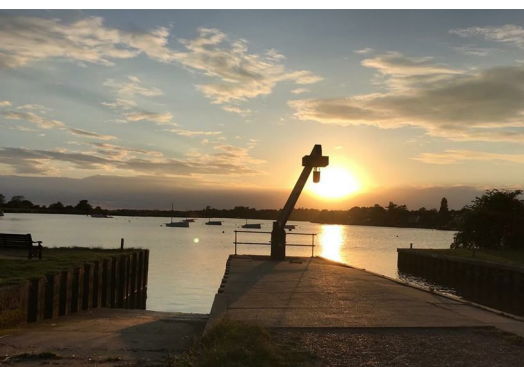

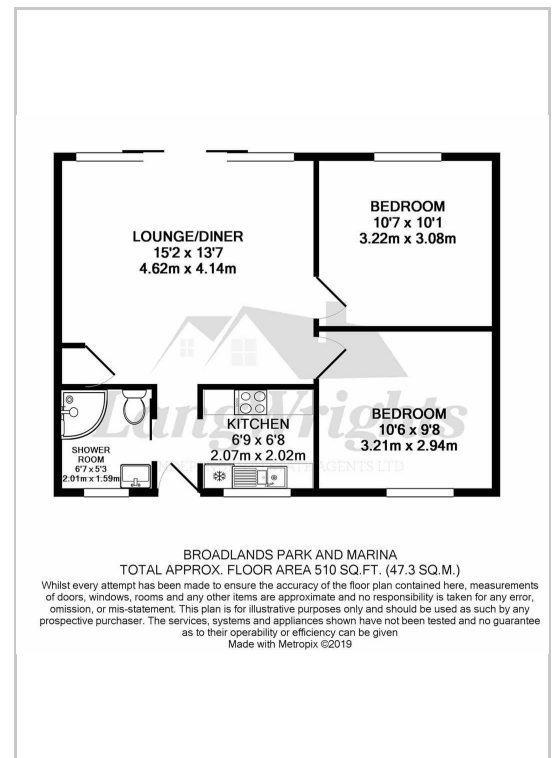

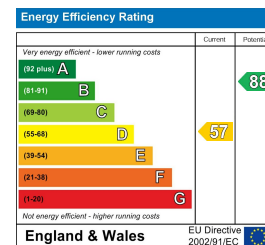
### Area Map
