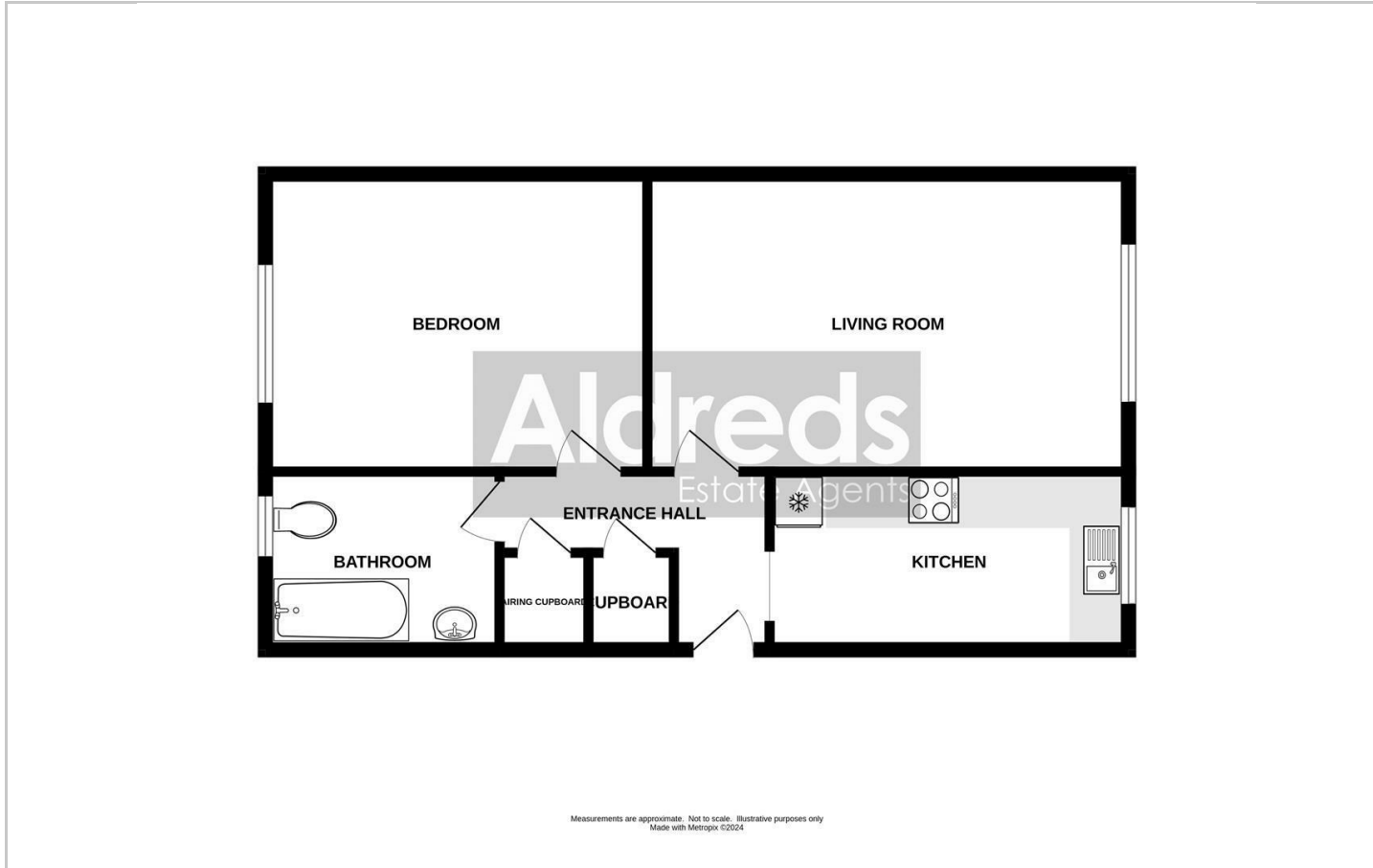

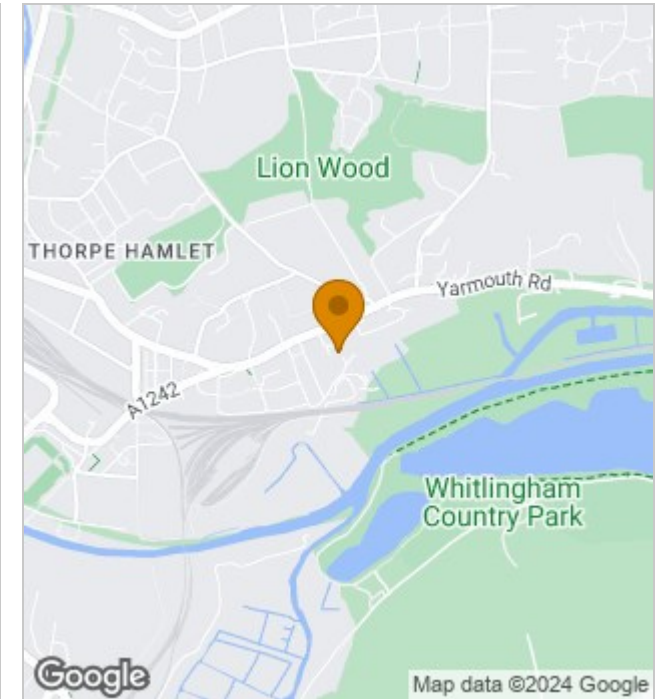

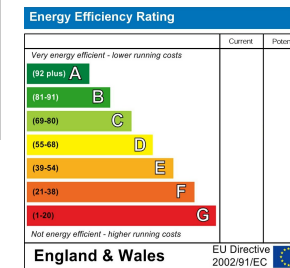
Floor Plans
