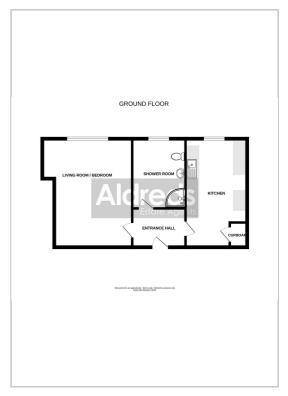

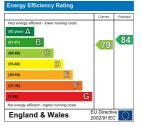
#### Area Map
