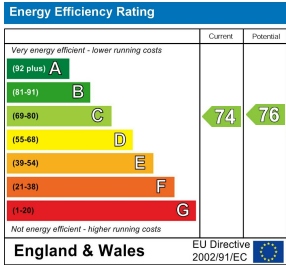
Floor Plans
