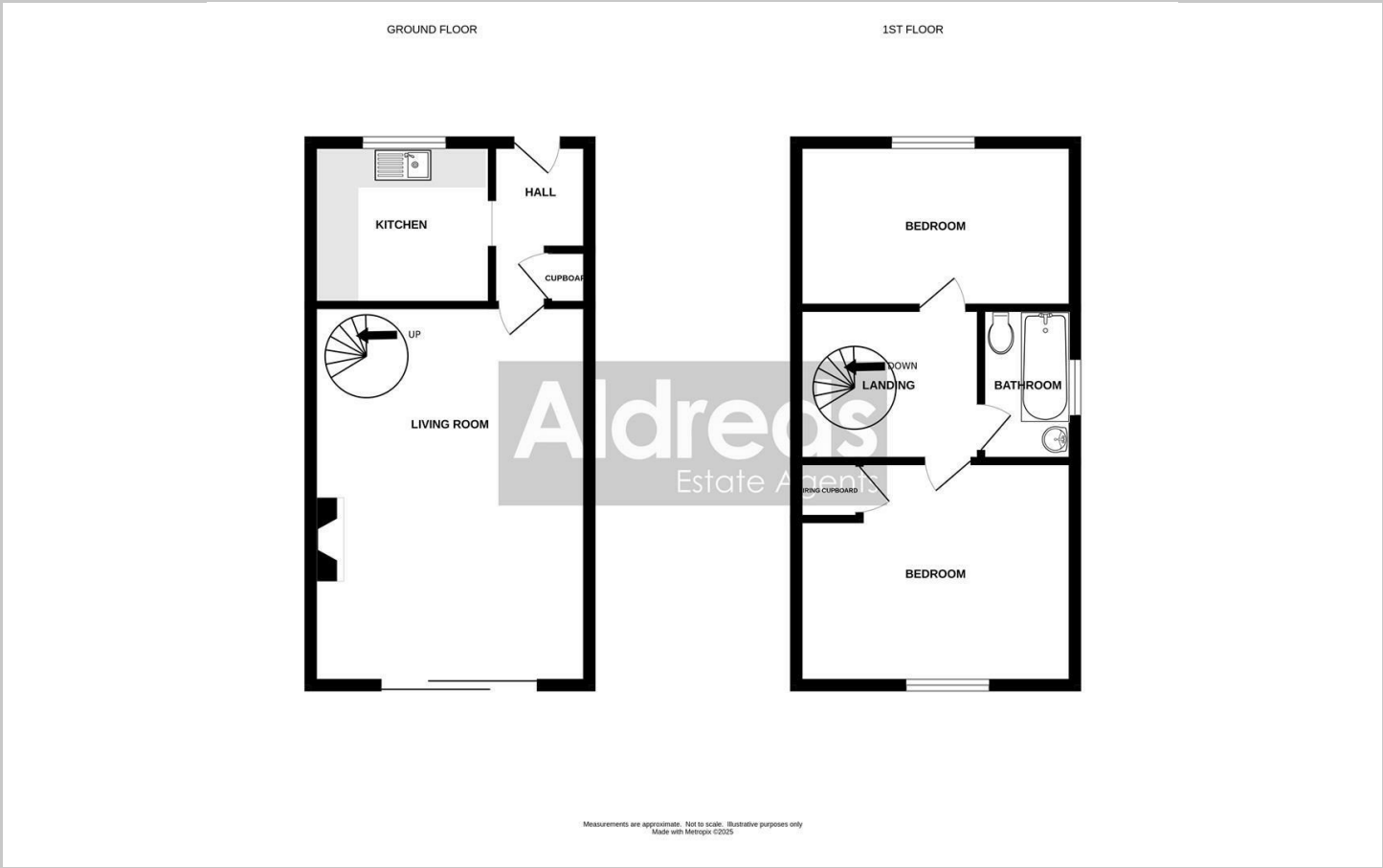

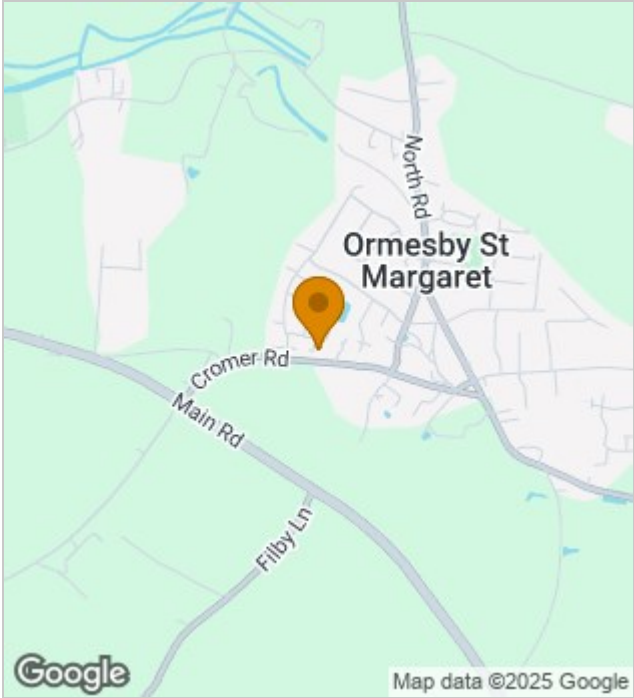

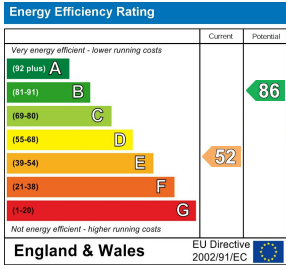
Floor Plans
