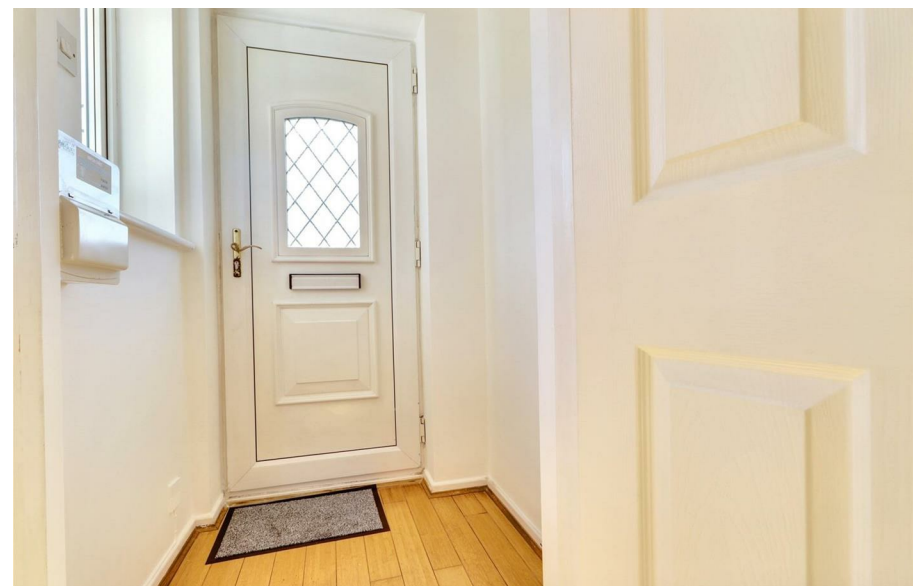

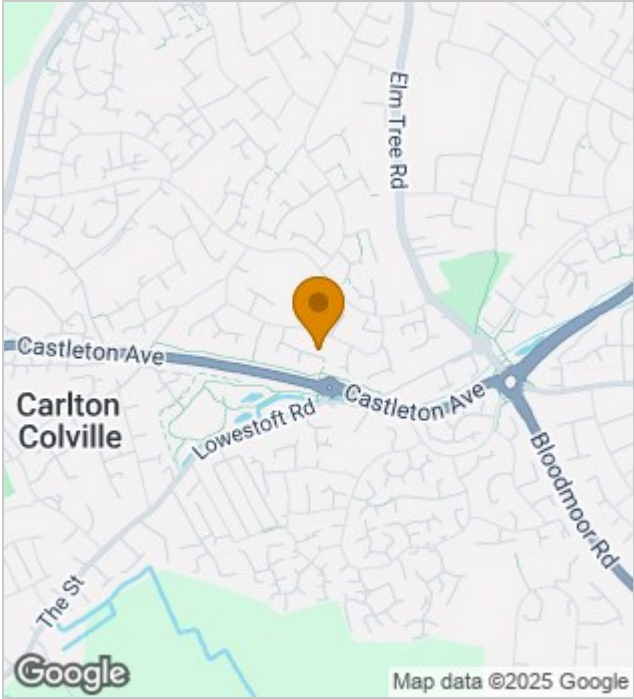

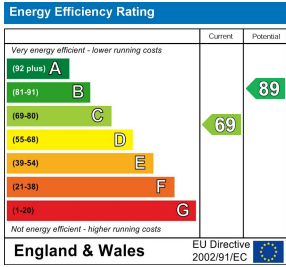
Floor Plans
