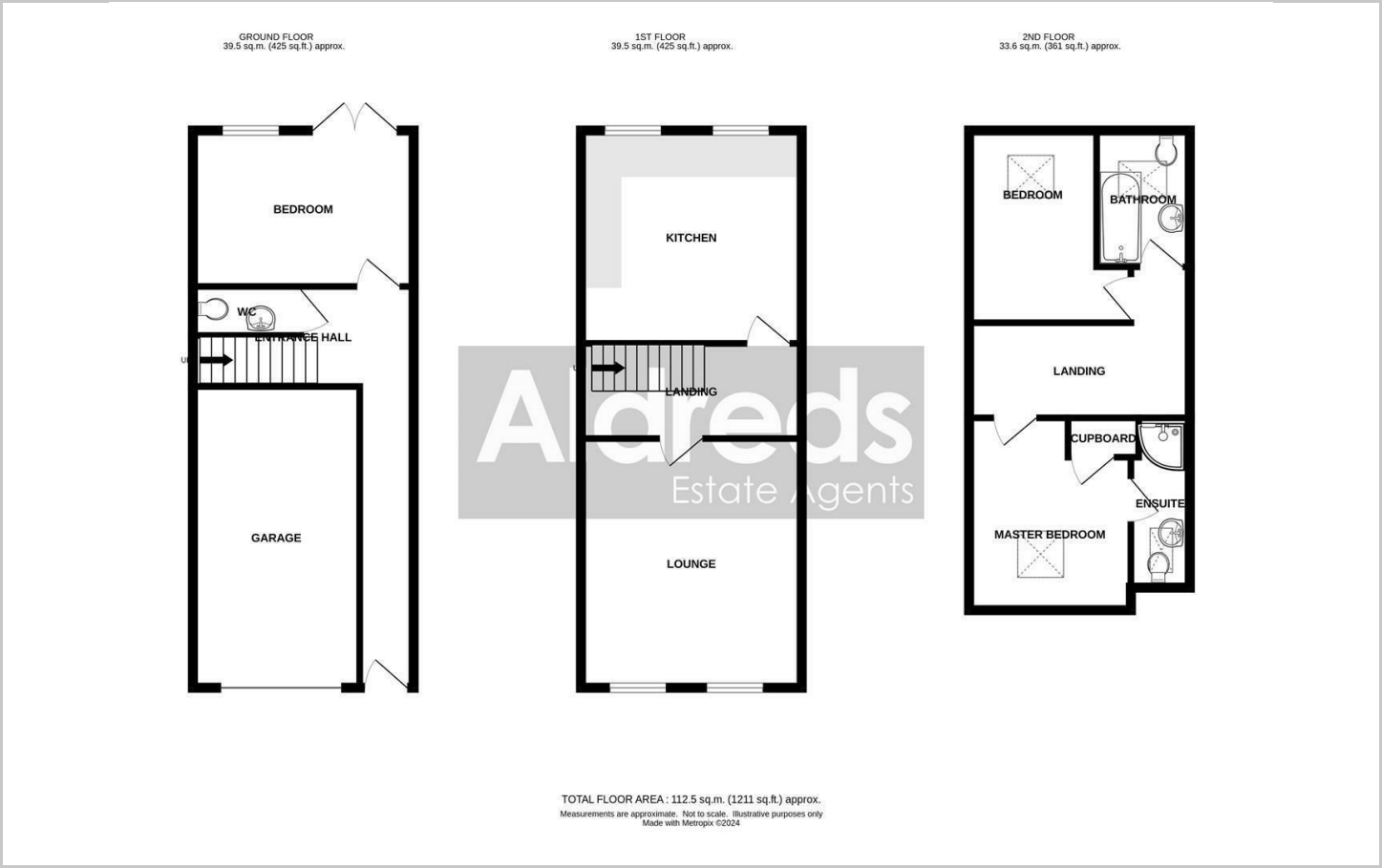

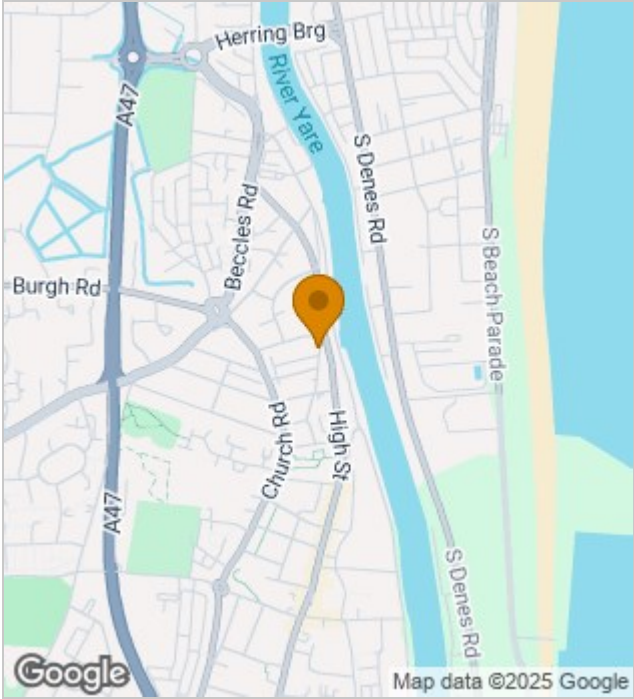

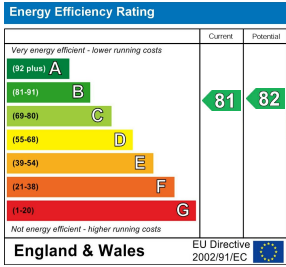
Floor Plans
