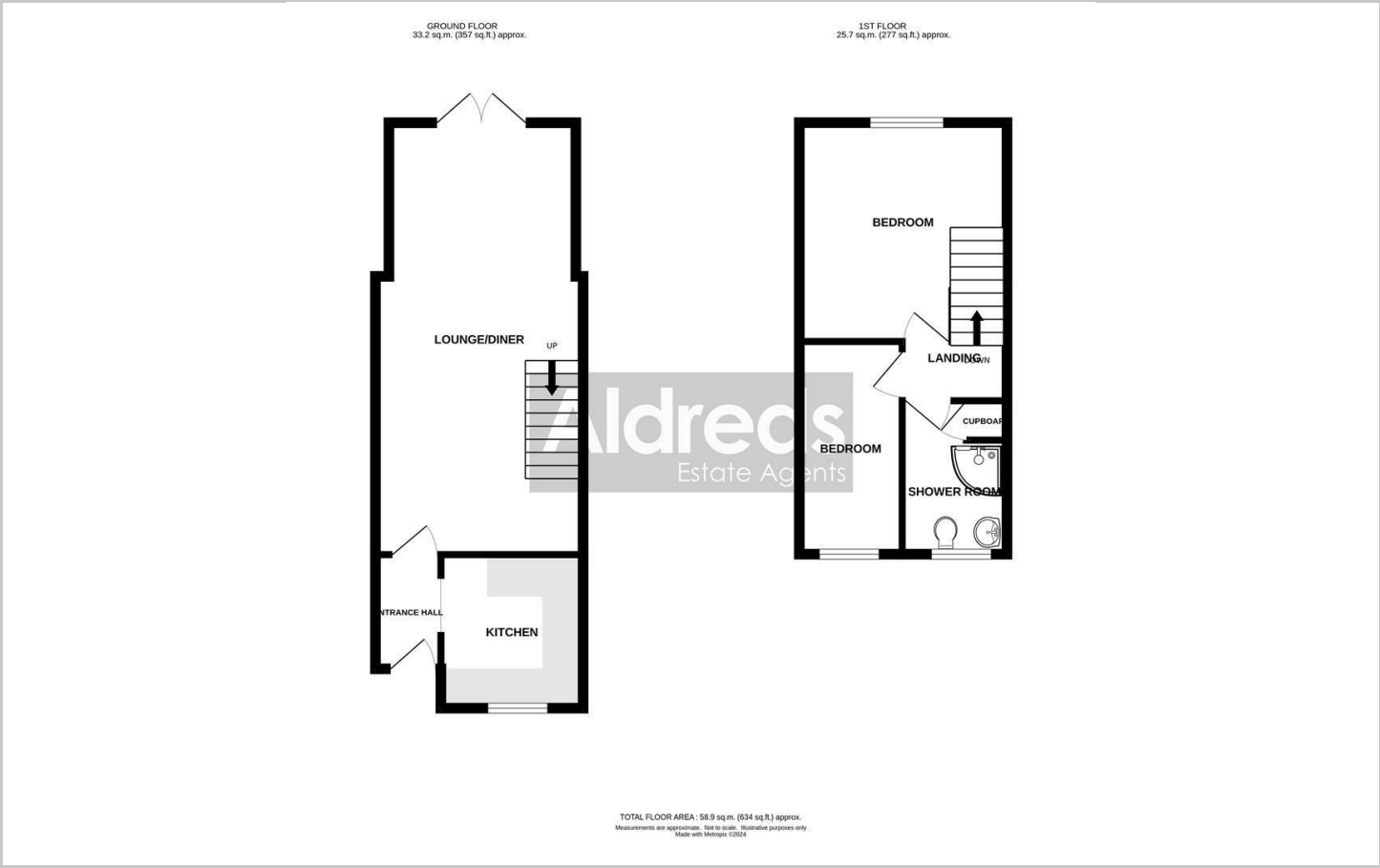

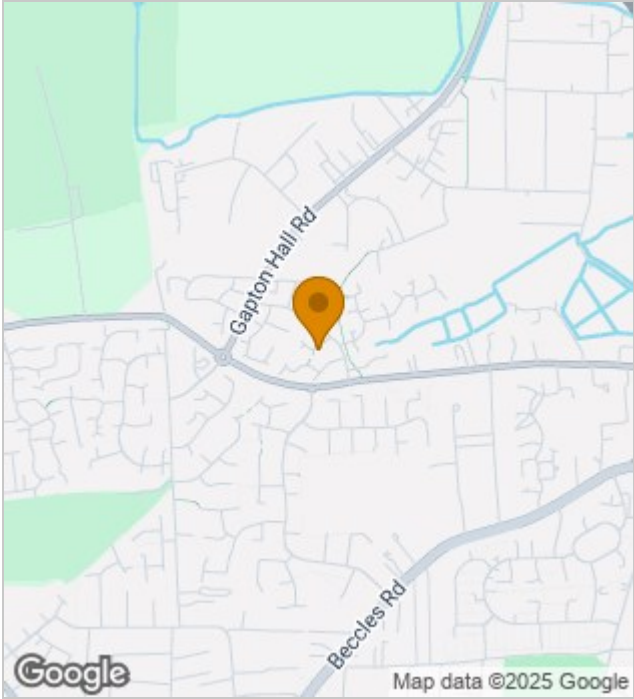

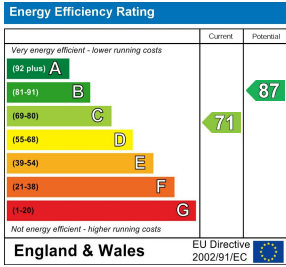
Floor Plans
