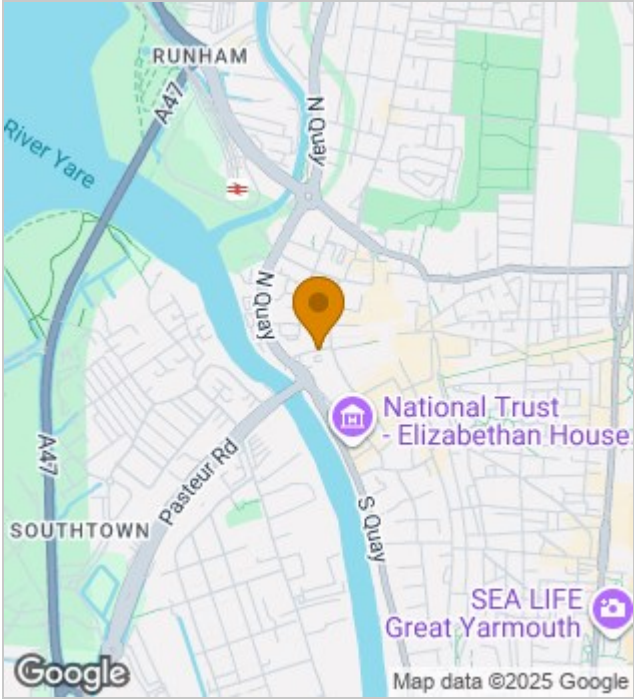

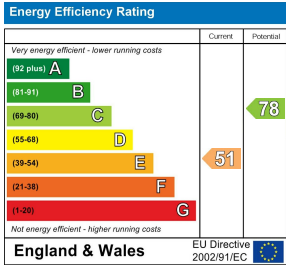
Floor Plans
