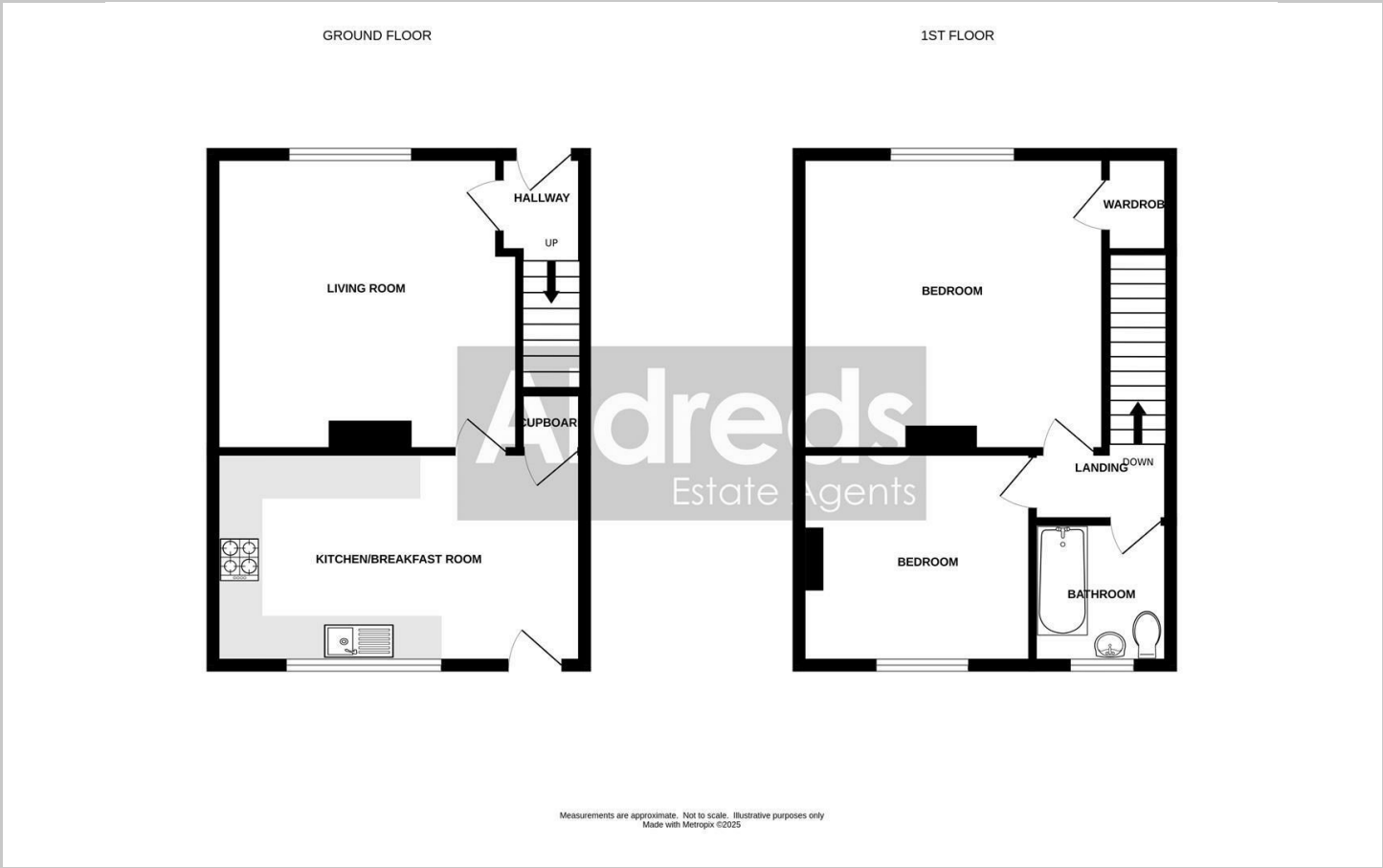

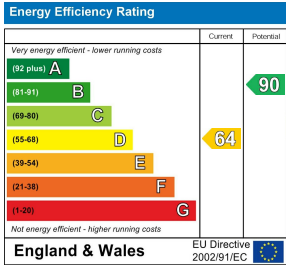
Floor Plans
