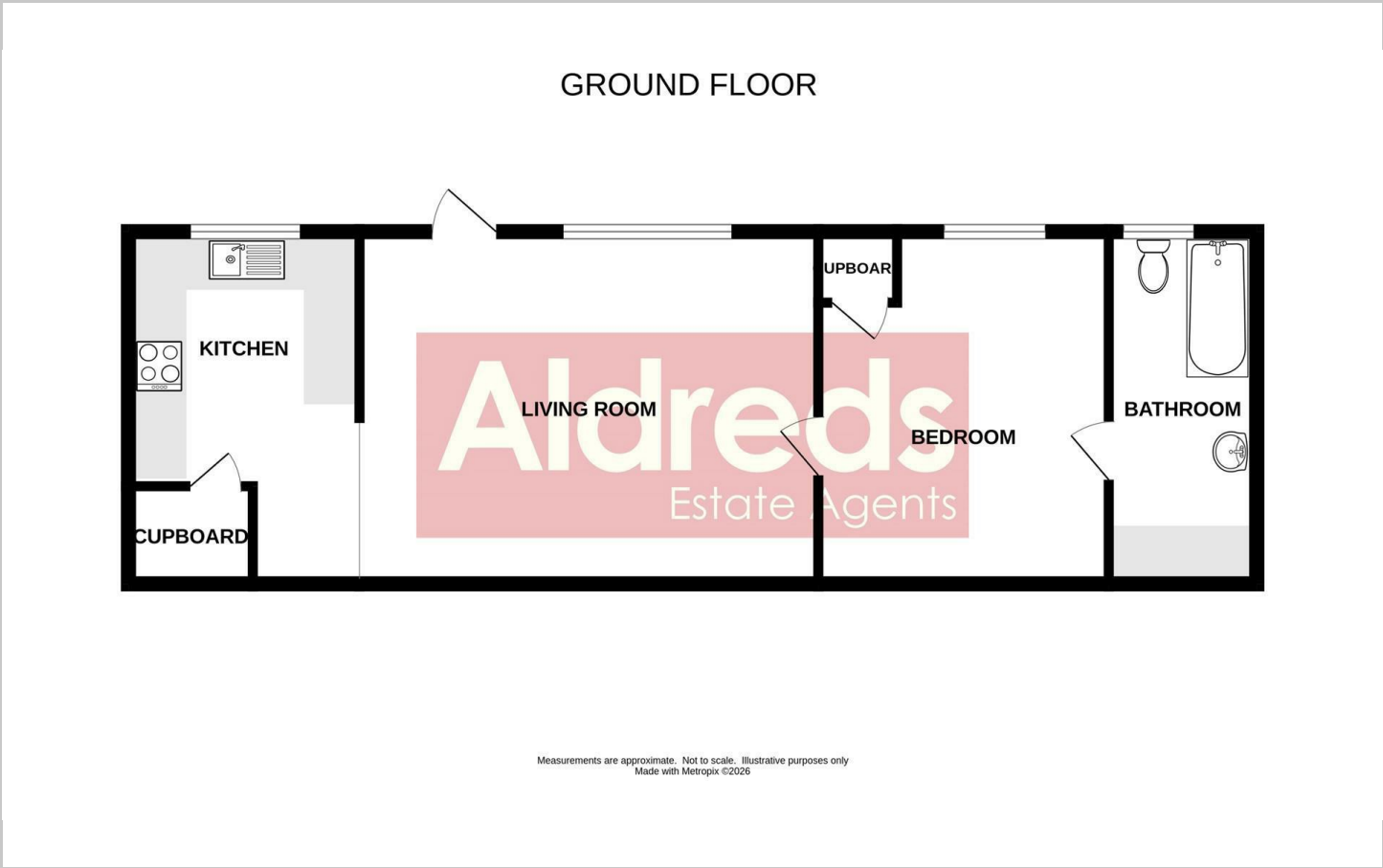

Floor Plans



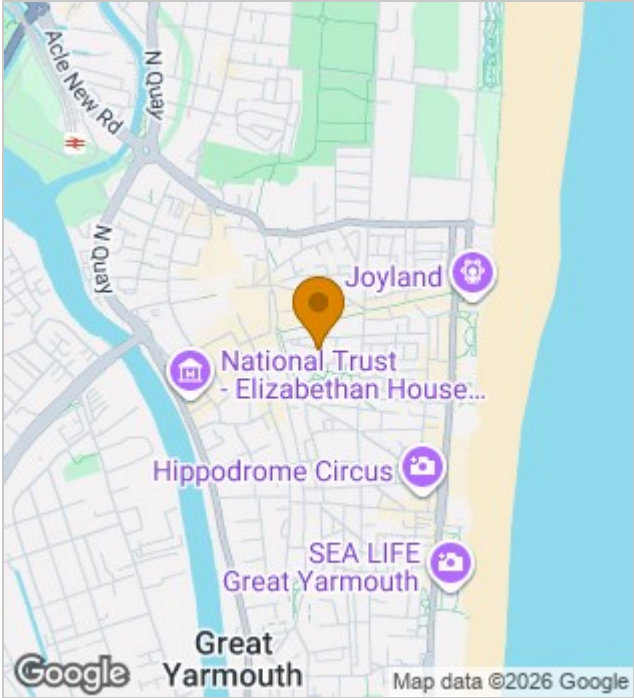
