



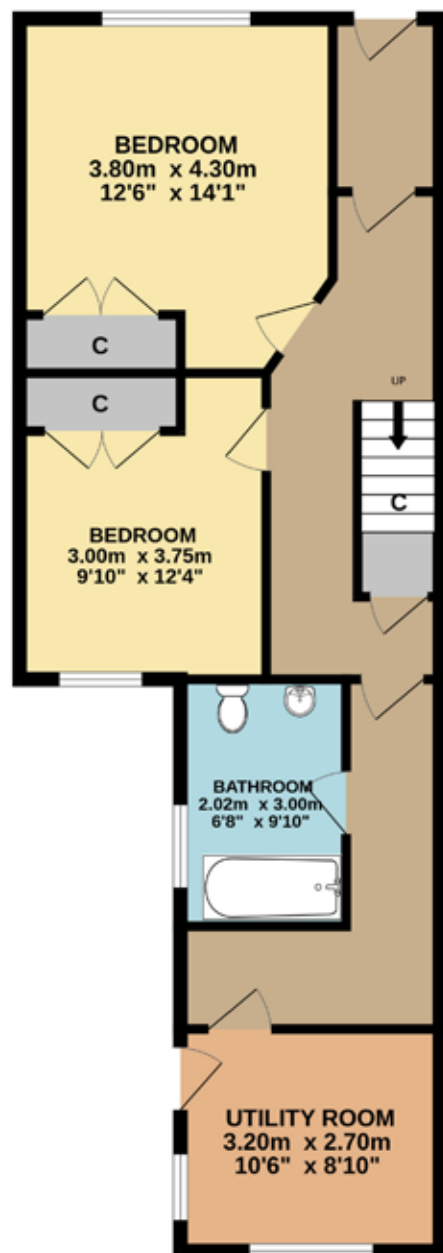

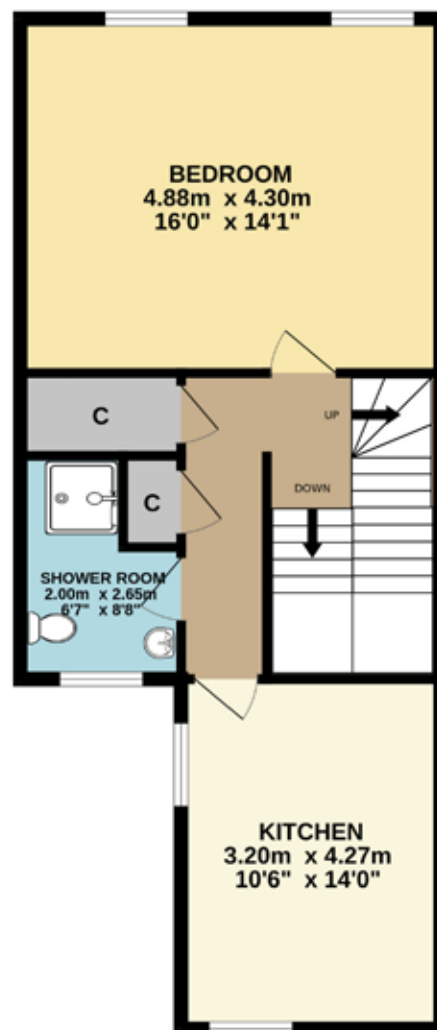

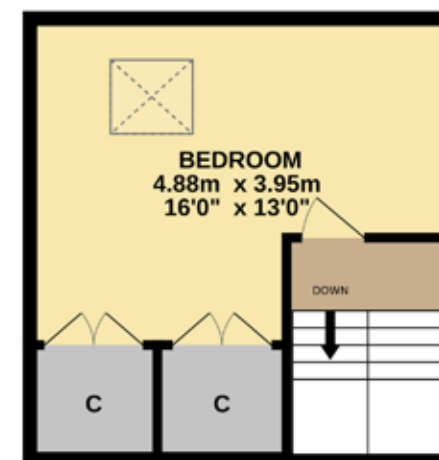
GROUND FLOOR

INTRODUCTION

No' 20 King Street is situated within the bustling picturesque market town of Castle Douglas, conveniently located with town centre amenities available straight from the doorstep.

No' 20 King Street is set over three floors offering bright, recently decorated, well-presented accommodation throughout comprising of three double bedrooms, two bathrooms, lounge, kitchen & a utility room. The accommodation is arranged as such that the lounge, kitchen and a bathroom are set on the first floor making the most of views across the one of the local parks and occupies a prime position to enjoy some annual events in Castle Douglas such as Douglas week celebrations and the fabulous Soapbox Derby. The property is within an easy walking distance of both primary and secondary schools, high street stores and three national supermarkets. Enclosed south facing garden grounds to the rear, which are shared with one other, offer a drying green set on a neat lawn.

As mentioned earlier, local services are conveniently located straight from the doorstep on to the thriving High Street of Castle Douglas (The Food Town), which offers all essential services and is renowned for its niche retailing with a wide range of traditional shops, delicatessens, craft beer and wine outlets, butchers, baker's grocers, craft outlets, etc. Both primary and secondary schools are also available within the town along with a modern health centre and a wide range of professional services, as well as two national supermarkets.

Communications to the area are good with the property lying in close proximity to the main A75 Euro Route, which provides quick access from the south via the M6 & M74. Cairnryan, the ferry link with Northern Ireland is a little over an hour's drive via the A75 and the international airports of Glasgow & Edinburgh within an easy drive of the property. There are mainline railway stations at both Dumfries and Lockerbie.

This area of Southwest Scotland enjoys one of the most varied and picturesque landscapes within Scotland, ranging from the moorland of the Southern Upland Hills to the bays and sandy beaches of the distinctive coastline. This is a rural county where agriculture and tourism thrive to form the backbone of the local economy. The area has been relatively unscathed by modern industry.

The region is well-known for the quality and variety of both field sports and leisure activities with the outdoor and sporting enthusiast extremely well-catered for as there exist the ability to take both shooting and fishing locally. Given the diverse landscape along with the proximity to the coast and local lochs, the area offers unique walks, sailing, cycling and for the golfer there is an abundance of good local courses with the region boasting no fewer than twenty-nine courses, the closest being within Castle Douglas.

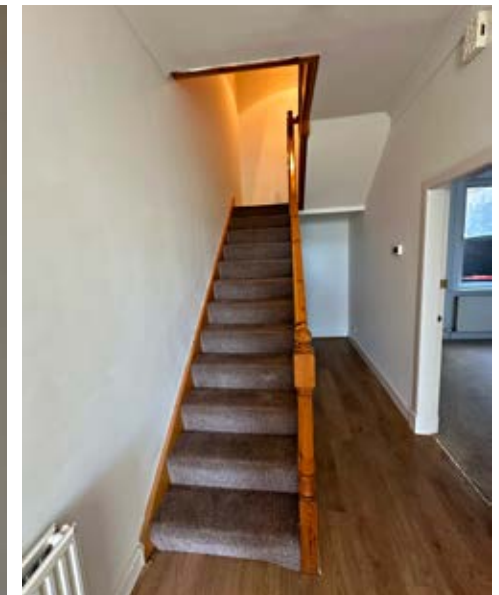

No' 20 King Street offers family accommodation over three floors, very briefly comprising:



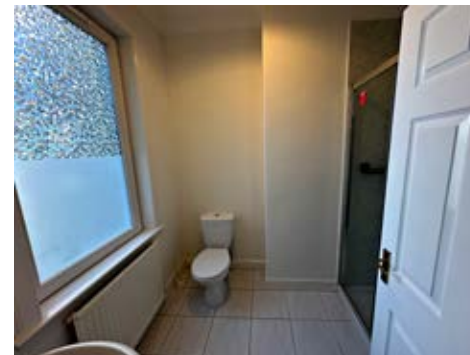
GROUND FLOOR

- **Central Hallway**
Laid to laminate flooring with stairs off to the upper floors and a spacious understairs cupboard.
- **Double Bedroom 1**
With built-in wardrobes and a window to the front.
- **Double Bedroom 2**
With a window to the rear and built-in wardrobes.
- **Bathroom**
With a bath, WC & WHB.
- **Utility Room**
With a stainless-steel sink set in a base unit, double aspect windows, door to the enclosed garden to the rear.



FIRST FLOOR

- **Upper Hallway**
With two built-in storage cupboards.
- **Lounge**
A spacious and bright family lounge with two windows to the front.



- **Bathroom**

With an enclosed shower cubicle, WC & WHB.

- **Kitchen**

A large family kitchen with ample room to house a dining table. There are a range of floor and wall units, built-in electric oven and gas hob.



SECOND FLOOR

At the mid-landing there is a door giving access to attic storage which is carpeted and partly plaster boarded. This could make a great hobby room or playroom.

- **Double Bedroom 3**

With a large Velux window to the front and built-in wardrobes.



OUTSIDE

As mentioned earlier, there are enclosed garden grounds to the rear which are mainly laid to lawns with a drying green. The garden grounds are shared with two other neighbouring properties.
