1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The subjects comprise a `C` Listed first floor flat occupying part of a detached two storey and attic dwelling house which has been converted into five flatted dwellings.

educational and transport facilities in the city of Inverness which lies	
approximately sixteen miles distant.

	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

Garages and Permanent Outbuildings	To the rear of the garden, there is a shed of stone construction. There is a car port space to the front of the property which is of timber manufacture contained under a sloping corrugated iron sheet roof covering. Visually inspected.
Outside Areas and Boundaries	There is an area of private garden ground pertaining to the property, accessed from the rear entrance door. The garden is laid to grass and gravel with a number of trees and shrubs. Access to the subject is taken directly off Ness Road which leads to a
	shared driveway with off-street parking provision for the five properties.
	The boundaries, where defined, are formed in stone walls.
	Visually inspected.
Ceilings	The ceilings are lath and plaster lined with painted and papered finishes.
	Visually inspected from floor level.

Internal Walls

The internal walls are lath and plaster and plasterboard lined with both papered and painted finishes.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors Including Sub-Floors

Flooring is of solid concrete construction, overlaid with slate flagstones, at ground floor level and suspended timber at first floor level.

There is no sub-floor area.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Internal Joinery and Kitchen Fittings

The internal joinery is of a painted softwood pattern comprising timber panel and glazed timber doors.

The internal stair is of timber manufacture with metal balustrades. There is an electrically operated chairlift installed at the staircase.

There is a basic fitted kitchen which has floor mounted units.

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

Chimney Breasts and Fireplaces

There is a stove installed at the fireplace within the kitchen/dining room which comprises a slate hearth.

There is an additional stove installed at the fireplace within a bedroom which comprises a tiled hearth.

The rear bedroom has an open fireplace, however, this appears to have not been in use for some time.

Visually inspected. No testing of the flues or fittings was carried out.

Internal Decorations

The internal decorations are painted and papered.

Visually inspected.

Cellars	Not applicable.

Electricity Mains electricity is connected. The electricity meter and fusebox are located within the hall at high level, with an additional fusebox located in the inner hall, again at high level. Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or

Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Gas	Not applicable.

Water, Plumbing and Bathroom Fittings

Water is from the mains supply. The plumbing installation where visible, comprises copper distribution pipes together with uPVC wastepipes.

There is a white three piece shower room suite which comprises an accessible electric shower, wash hand basin and WC. In addition, there is a WC toilet facility which comprises a wash hand basin and WC, accessed off the hall/landing area.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and Hot Water

There is a full oil fired central heating system which supplies a series of water filled radiators.

Domestic hot water is provided by the `Worcester Greenstar Heatslave` combination central heating boiler which is installed within the kitchen.

The oil storage tank is of uPVC manufacture and installed within the garden area.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage

Drainage is assumed to be to the main public sewer.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Fire, Smoke and Burglar Alarms

There are smoke/fire alarms installed of which we understand comply with the new smoke alarm regulations.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to Inspection

The property was fully furnished at the time of our inspection and the services were not tested.

No access was obtained to any roof void areas.

Not all windows and doors were tested at the time of inspection.

No access was obtained into the cupboard at the half landing.

A restricted inspection was possible only of the roof and chimneys from ground level.

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.


Only the subject flat and internal communal areas giving access to the flat were inspected.

The building containing the flat, including any external communal areas, was visually inspected only to the extent that the surveyor is able to give an opinion on the general condition and standard of maintenance.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a nondisruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

	There is evidence of woodworm to flooring. We understand that treatments were carried out in the mid 1990's, however any guarantees are likely to have expired. Dampness was evident to internal wall linings adjacent to the rear entrance door.

Notes	We understand that works have been carried out to the chimney stack in October
	2024 by Wyvis Roofing.
	Weathering was noted to additional chimney stacks within the block. It should appreciated that they are of an age where on-going maintenance will be required, particularly to flashing details to ensure water tightness.

	Roofing including Roof Space

Notes	Roofing works have been carried out by Wyvis Roofing in November 2023. Copies of these works should be obtained.
	A number of cracked and slipped slates were evident to other areas within the block of properties.
	The roof is of a complex design and all junctions/valleys are potential weak points. A regular repair and maintenance programme should therefore be envisaged and it would be prudent to have an annual inspection carried out.

	Rainwater Fittings
Repair Category	2
Notes	In accordance with good maintenance practice, gutters should be regularly cleared of vegetation and debris.

	Main Walls

Notes	Weathering was noted to exposed areas of stonework at the windows.



Windows, External Doors and Joinery

Repair Category	2
Notes	Seals to some of the double-glazed windows have failed causing condensation between the panes.
	Cracked glazing was noted to some of the single glazed, timber sash and casement windows. Decay was also noted to window frames.
	Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.
	Weathering/rot was noted to the rear entrance door.

	External Decorations

Notes	The external decorations to some of the windows is weathered/decayed and an overhaul should be expected.
	We understand the entire building was painted in 2022.

	Conservatories / Porches

	Communal Areas

Notes	Weathering was noted to the paintwork finish at the communal entrance door. Dampness was evident to internal wall linings adjacent to the communal entrance door.

Notes	The outbuildings are in poor condition with the shed in a dilapidated state of repair. Repairs should be carried out to bring it to an acceptable standard for its purpose.

Notes	Maintenance is required to the stone boundary walls with areas of defective render and open pointing noted.
	You should verify with your conveyancer the extent of the boundaries attaching to the property.

Notes	There is a run in the flooring appearing to be as a result of previous movement. On the basis of a single inspection this appears long-standing and non-progressive. There is evidence of woodworm to exposed floor timbers.

Notes	The internal joinery is showing some signs of wear and tear and upgrading during routine decoration is thought necessary.
	Some decay was noted to skirting boards within the living room area.

Notes	All flue linings should be checked, repaired if necessary and swept prior to the fires being reused. It is assumed that the wood/multi-fuel apparatus has been installed in asserdance with
	It is assumed that the wood/multi fuel apparatus has been installed in accordance with the manufacturer's recommendations in particular regard to flueing and ventilation. The appliance was not tested.
	Positive moisture meter readings were obtained adjacent to the fireplace within the kitchen/dining room. We understand that works have previously been undertaken to this area and it may be a case of drying out. This should be monitored.

Notes	Flaking paintwork and peeling wallpaper were noted to some ceiling linings.

Notes	Not applicable.

	Electricity

Notes	The electrical installation is of mixed age and includes a number of older sections. It will be necessary to have the installation checked by a suitably qualified electrician and upgraded as necessary.
	The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.

4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

The subjects form part of a block of flats and it has been assumed that maintenance/repair costs of the common parts of the building and external grounds will be shared on an equitable basis with the adjoining proprietors. It is therefore assumed that the costs of repairs detailed within this report which relate to these areas should be apportioned accordingly, although exact liability should be confirmed.

There is a shared access driveway and a shared parking area. The conveyancer should check the legal arrangements are adequate.

During the inspection it was observed that past timber/damp proofing repairs have been carried out within the property and all specialist reports and guarantees should be obtained, studied and authenticated prior to purchase. If such reports cannot be obtained or do not exist then prior to purchase an inspection and report should be prepared on the whole property from a reputable firm of timber specialists so that any existing repair works or remedial works required are completed to a guaranteed standard.

The property is a `C` Listed building and as such the cost of repair or reinstatement works to the exterior of the building are likely to be higher than normal. Any works considered necessary will require to be carried out in consultation with the local authority planning department and Historic Scotland.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

Estimated Reinstatement Cost for Insurance Purposes

£1,000,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £1,000,000 (ONE MILLION POUNDS STERLING).

Valuation and Market Comments

£310,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £310,000 (THREE HUNDRED AND TEN THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. No

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.



The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.



2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

2.3.3 Category 1:

No immediate action or repair is needed.

WARNING

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The Surveyor will collect physical data from the Property and provide such data in a format required by an accredited energy company. The Surveyor cannot of course accept liability for any advice given by the energy company.

The last section of the Report contains matters considered relevant to the conveyancer (solicitor). It also contains the Surveyor's opinion both of the market value of the Property and of the re-instatement cost, as defined below.





The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. 1 Internal wall insulation

Internal wall insulation involves adding a layer of insulation to the inside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. 2 Double glazed windows

Double glazing is the term given to a system where two panes of glass are made up into a sealed unit. Double-glazed windows may also reduce noise, improve security and combat problems with condensation. Building regulations apply to this work and planning permission may also be required, so it is best to check with your local authority on what standards need to be met. A building warrant is not required if the windows comply with the current requirements.
