This is a fantastic opportunity to acquire a home of exceptional proportions in a highly desirable setting.

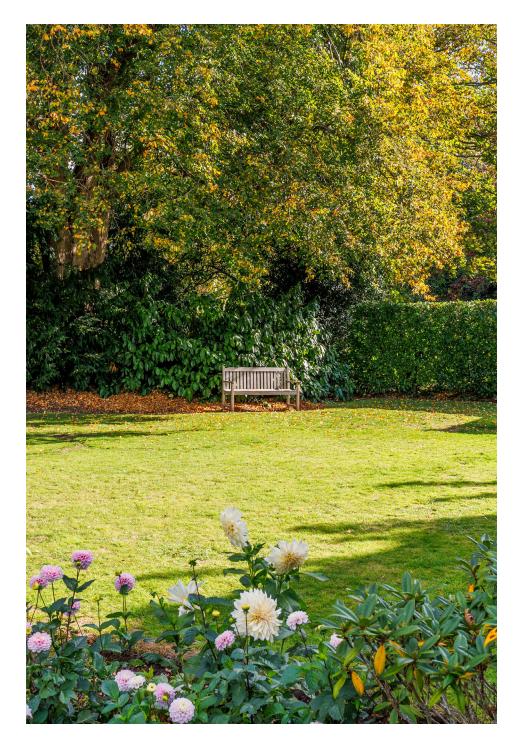




LOCATION
