
Properties can be let if they have an energy rating from A to E.

Energy rating and score

Primary energy use

The primary energy use for this property per year is 319 kilowatt hours per square metre (kWh/m2).

How this affects your energy bills

An average household would need to spend £2,161 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

You could **save £993 per year** if you complete the suggested steps for improving this property's energy rating.

5. Condensing boiler	£2,200 - £3,000	£335
6. Solar water heating	£4,000 - £6,000	£69
7. Replace single glazed windows with low-E double glazed windows	£3,300 - £6,500	£47
8. Solar photovoltaic panels	£3,500 - £5,500	£464
9. Wind turbine	£15,000 - £25,000	£1,025
