Fantastic two bedroom, two bathroom, 4th floor property set within Wimhurst Court, which is originally part of the Phoenix Works development by Fairview Homes.

Accommodation spans 847 sq. ft. and includes an spacious open-plan living area with full height windows leading to a generous private balcony which leads out from the living room providing direct views overlooking Bartlett Park with far reaching views towards Canary Wharf and a modern fitted kitchen suite with integrated appliances, two good sized bedrooms both with en suite's with smart fittings and fixtures. The property comes with a secure underground car parking space.

Phoenix Works is in a quiet residential area suitable for families and working professionals, a gated development with underground parking spaces, double security doors and video entry phone systems.

Directly opposite the open, green space of Bartlett Park, Chrisp Street market, a few minutes walk away, is an authentic East End street market, with over 70 stalls, a monthly 'street food' event, traditional 'pie and mash' and other cafés. Westfield Stratford City shopping centre is under half an hour away. The apartment is moments' walk from Limehouse Cut Canal. Closest transport links are Langdon Park DLR (0.4 miles) and Westferry DLR station (0.7 miles).







