


13A QUEEN SQUARE BAI

SITUATION

Occupying a prominent position on the south side of Queen Square, this exceptional maisonette lies within one of Bath's most admired Georgian settings. Designed by John Wood the Elder between 1728 and 1735, the square was Bath's first architectural landmark and remains a vibrant part of the city centre. Its formal gardens, enclosed by wrought iron railings, create a tranquil contrast to the surrounding Georgian façades.

Just a few minutes' walk away are The Circus, Royal Crescent, and Milsom Street, together with Bath's wide selection of independent retailers, cafés, and restaurants. The city also offers excellent schools, cultural venues, and easy access to Bath Spa station, which provides regular services to London Paddington in around 75 minutes.



THE MAISONETTE

Entered via its own private front door, the property combines Georgian scale with a clean, modern aesthetic.

The spacious kitchen and dining room is the heart of the home, featuring vaulted ceilings, bespoke cabinetry in a two-tone finish, quartz worktops, and Bosch appliances. Brass fittings add warmth, while sash windows flood the space with natural light.

A generous reception room to the front retains period proportions and a feature fireplace, creating a calm and versatile living area.

There are two double bedrooms, both finished in soft, neutral tones. The principal bedroom enjoys access to a private south-facing terrace, offering a rare outdoor retreat in the city.

The bathroom has been designed with the same attention to detail, featuring limestone-style tiling, a fluted oak vanity, brushed brass fittings, and a separate bath and shower.

Throughout, the maisonette combines timeless materials and craftsmanship with thoughtful design, creating a home that feels both elegant and effortless.
