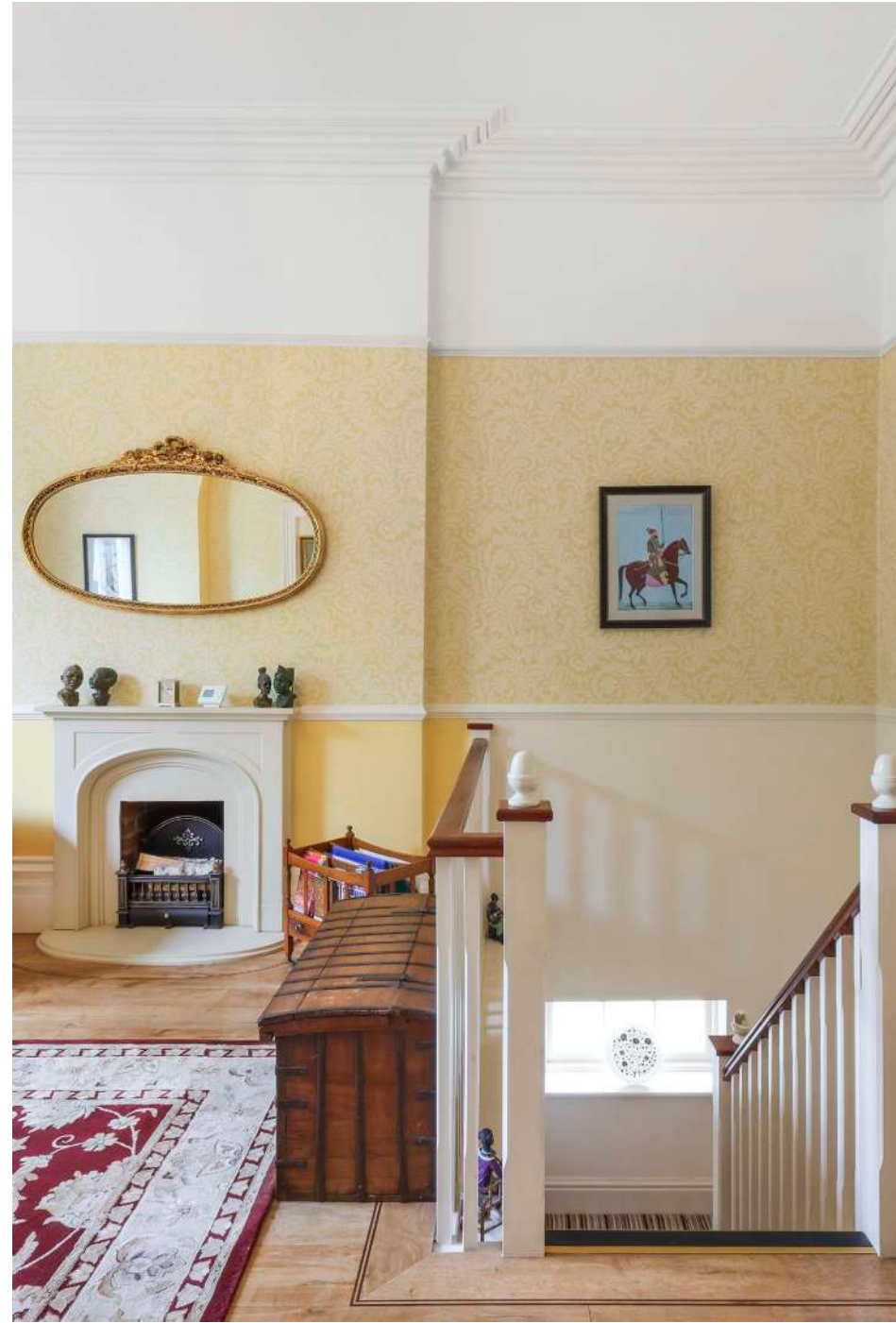

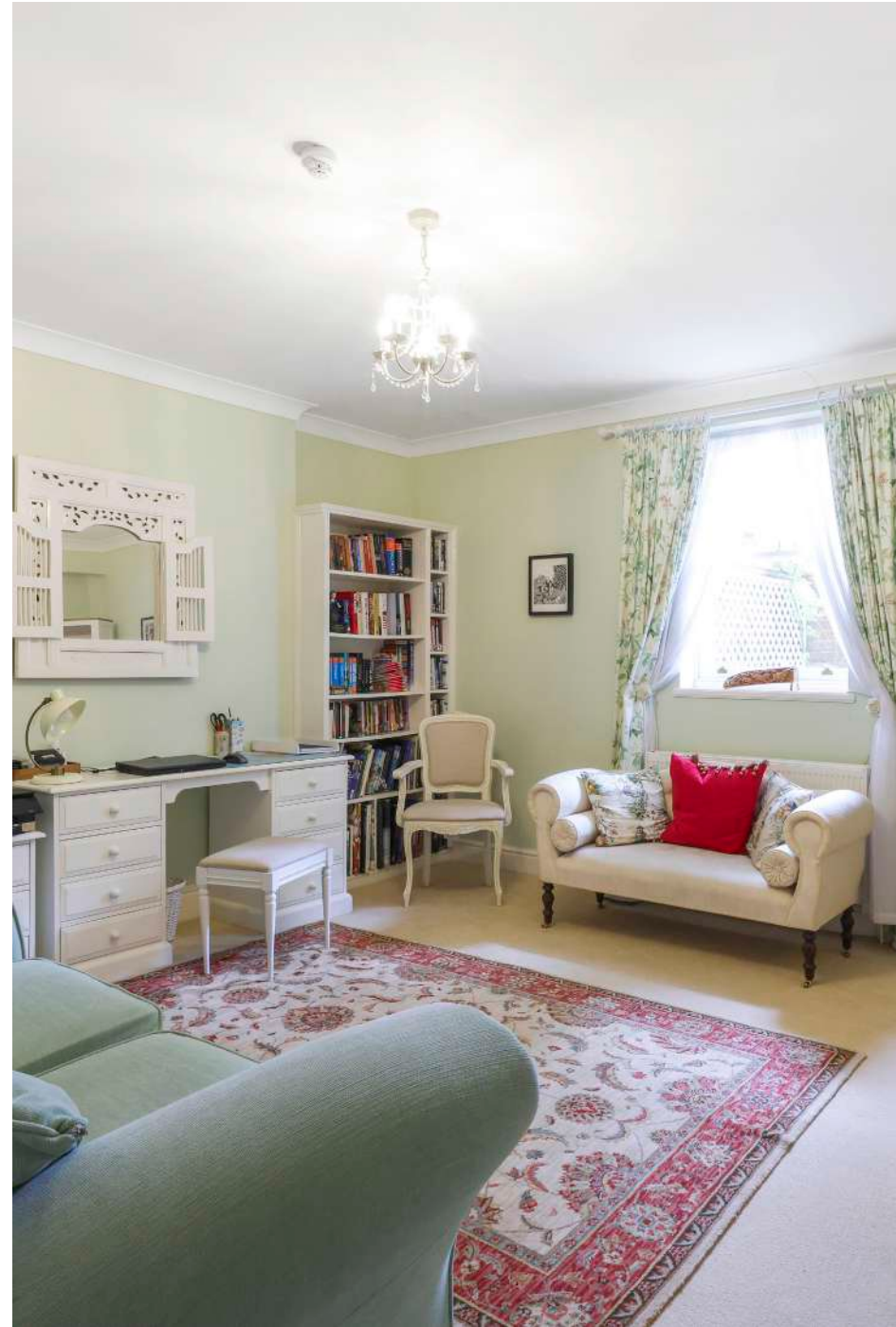
BEDROOMS AND BATHROOMS
