Accessed via a private lift that opens directly into the apartment, the property also benefits from stair access for added convenience. The accommodation is beautifully arranged, featuring a spacious open-plan sitting and dining area with elegant front-facing views over Imperial Square. To the rear, the well-appointed kitchen/breakfast room includes a central island, ample wall and base units, and direct access to one of the roof terraces.

There are three well-proportioned bedrooms, two of which have en suite bathrooms. The third bedroom is located near a separate cloakroom and includes built-in storage. The principal suite enjoys views across Imperial Square and features a dressing room and a luxurious en suite bathroom. The two rear bedrooms also enjoy access to the rear terrace, enhancing the sense of space and light.

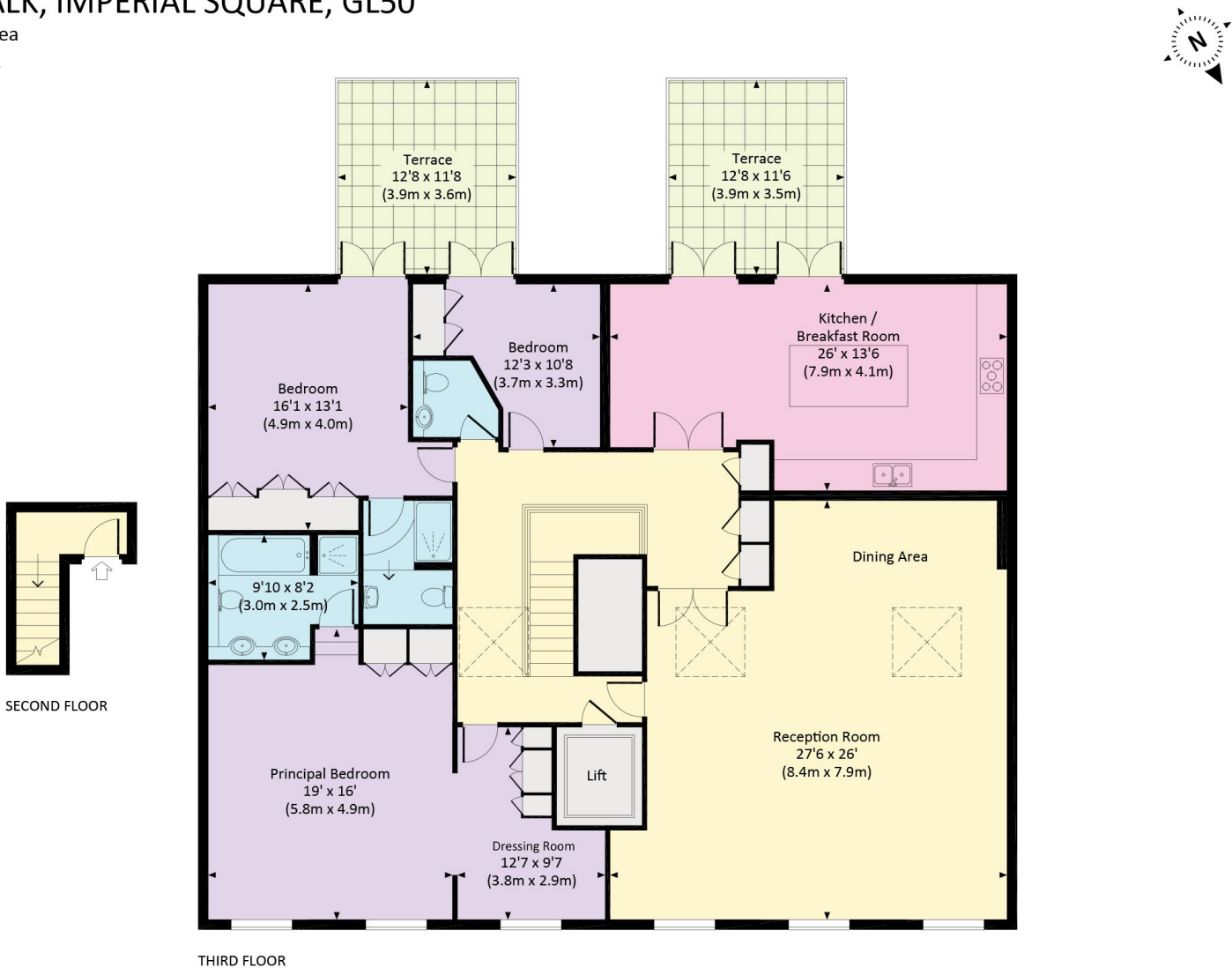
Location
