THE PROPERTY

Bowron Cottage is a Grade II listed five bedroom cottage set over three floors on the edge of Latton. The property is well presented and offers spacious, practical living throughout whilst retaining many period features, good ceiling heights and exposed beams.

LOCATION

Latton is a small village just a short distance from Cricklade, a historical and picture sque town in north Wiltshire, and is halfway between Swindon and Cirencester. Latton has an active village community with a monthly village cafe, village pub and allotments are available for villagers.

The village features the beautiful Grade I listed C12th Church of St John the Baptist, thought to have been built by Circnester Abbey, and is surrounded by lovely countryside, ideal for walking, riding and cycling.

The property is a short walk from The Crown at Cerney Wick. It is also at the southern gateway to the Cotswold Water Park, which offers sailing, water/jet skiing, fishing, and bird watching.

The neighbouring village of Down Ampney has a community shop, tennis courts and a village hall.

The nearby town of Cricklade and Cirencester offers a museum and many shops, pubs and restaurants.

Cirencester 7 miles, Swindon 11.4 miles, Cheltenham 22 miles, Oxford 41 miles, Bristol 43 miles (all distances are approximate).





OUTSIDE

To the rear is a gravel driveway, with parking and a single garage. To the front is a high hedge surrounding the garden, offering a tranquil private space.

There are mature plants, shrubs, trees, areas to sit down and relax, and an outdoor dining area.

A gate leads out to the village, perfect for country walks and exploring the area.


