Kew Gardens and Richmond Park, with its 2,500 acres of stunning deer inhabited parkland, are both around a mile away. Richmond station provides a direct service into London Waterloo, plus District Line Underground and Overground services. The A316 is close by that joins the M3, allowing a fast transfer to the M25 or continuation to the west. The opposite direction takes you directly into central London, with Hyde Park Corner being just over eight miles away.
