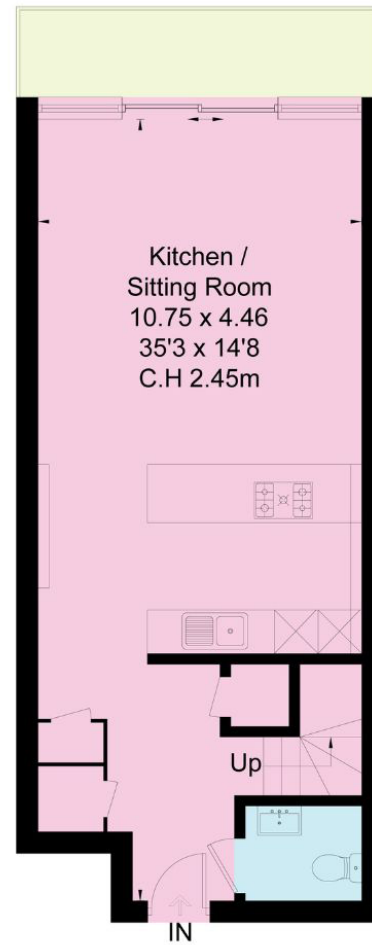
The property includes comfort cooling and underfloor heating, ensuring optimal climate control throughout the seasons.

There are two secure car stacker spaces at ground floor. Additionally, an underground bike store and a storage locker provide ample space to accommodate the diverse needs of modern urban living.

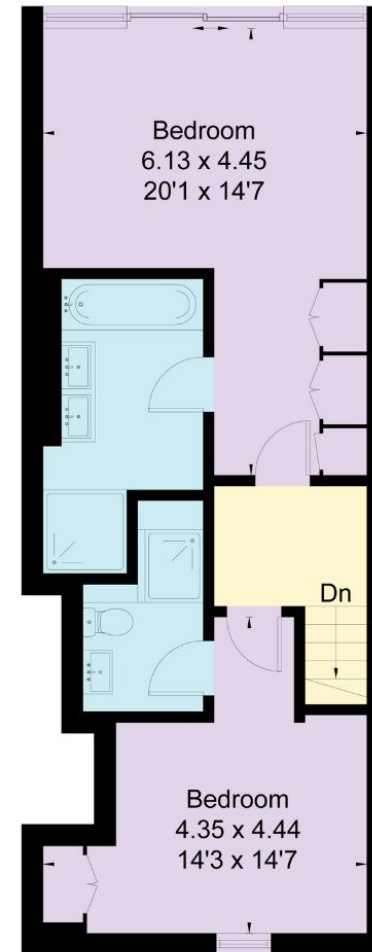








Second Floor
