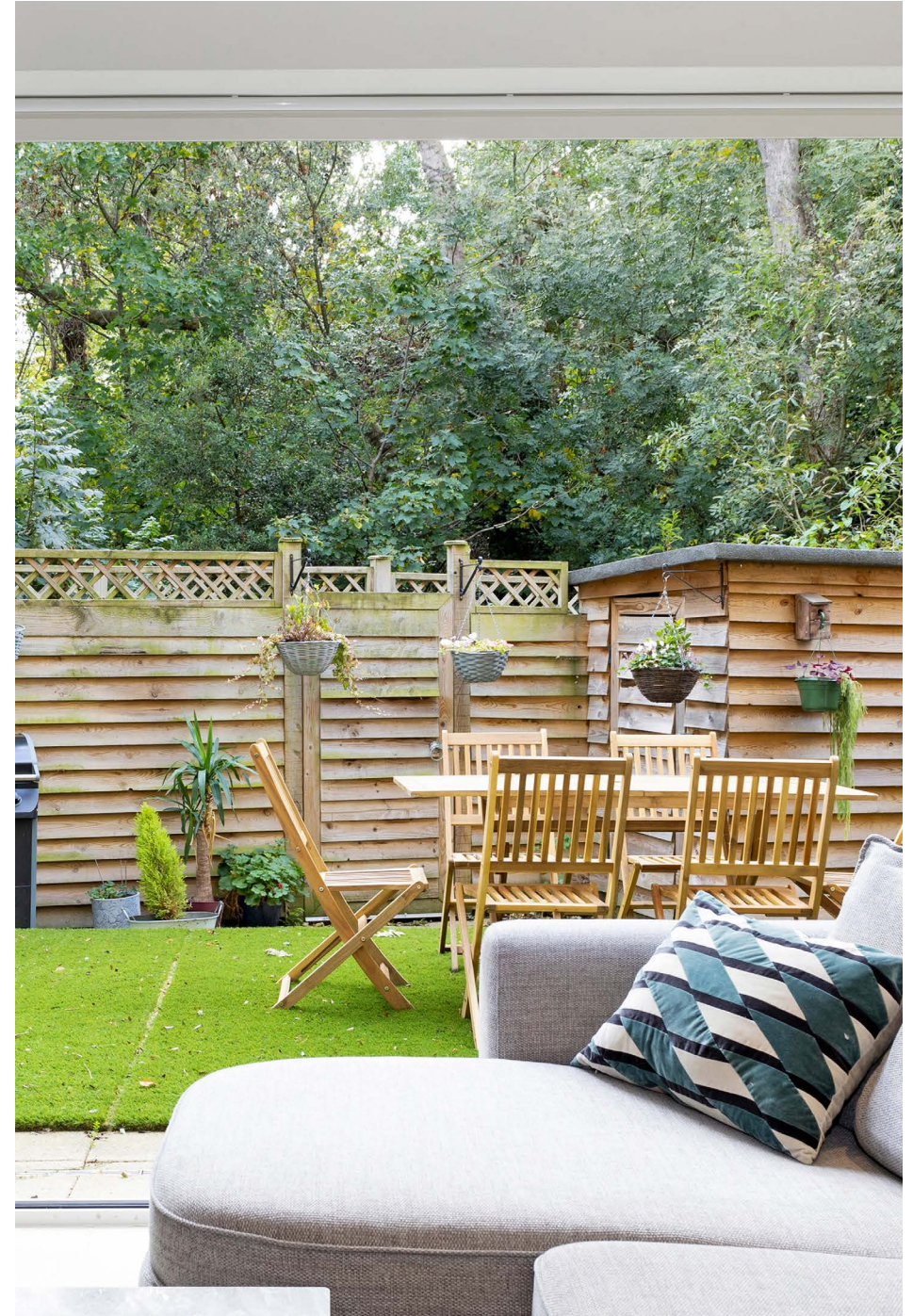

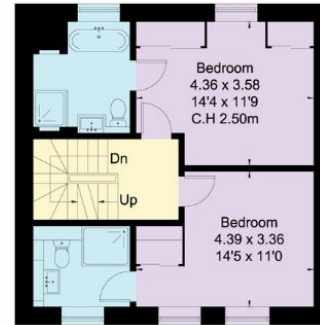




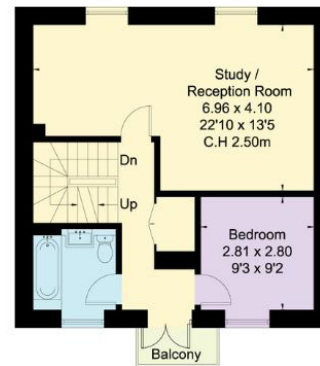




Ground Floor
