This ground floor converted Studio apartment situated in this impressive grandeur building is now offered with vacant possession. The property is located within a stones throw of Slough High Street and mainline railway providing the Elizabeth Line into London.. 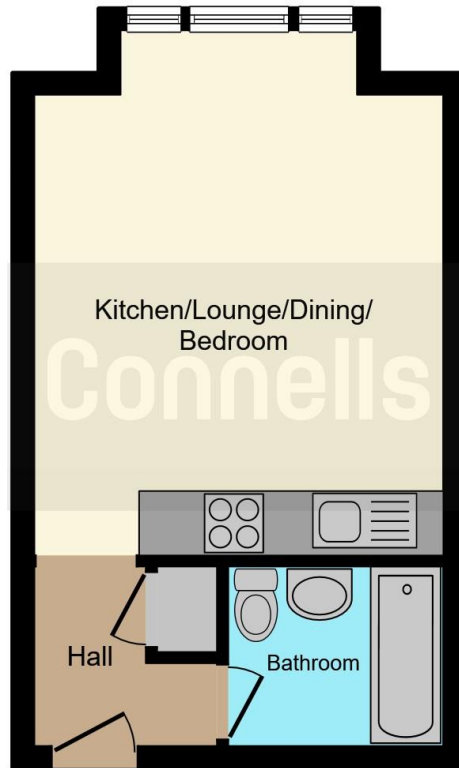
