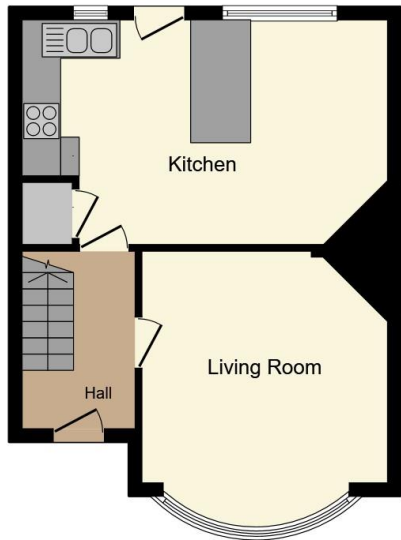

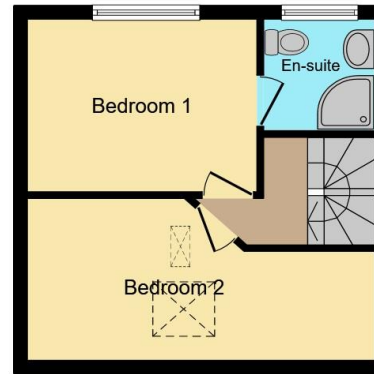




**Ground Floor**
