NO UPWARD CHAIN This first floor flat is situated in the residential area of Tile Hill to the west of the city close to local amenities including access to Birmingham, Warwick University and motorway links. The accommodation briefly comprises lounge, fitted kitchen, three bedrooms and a fitted bathroom.

Bedroom Three


10' 4" x 7' (3.15m x 2.13m) Single glazed window to the rear elevation.
