Property Description

Superb commuter links are provided into London from nearby train stations as well as road access from the M1. For the keen Rambler and Walker, countryside sits directly on your doorstep providing unrivalled walks and nature trails locally.

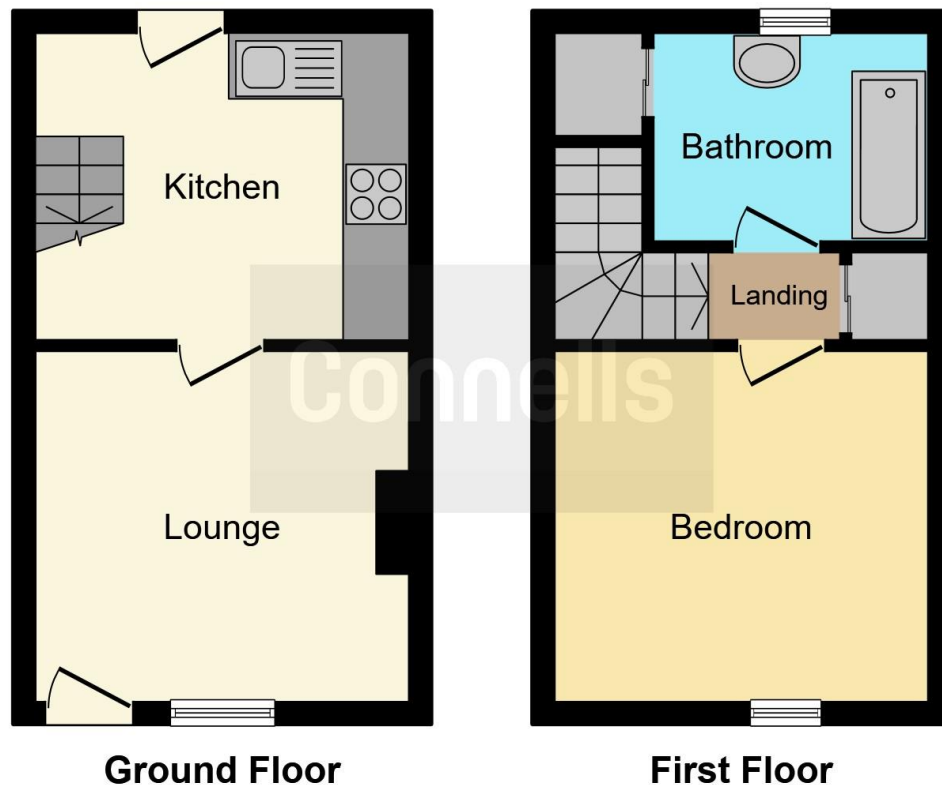
