### Property Description

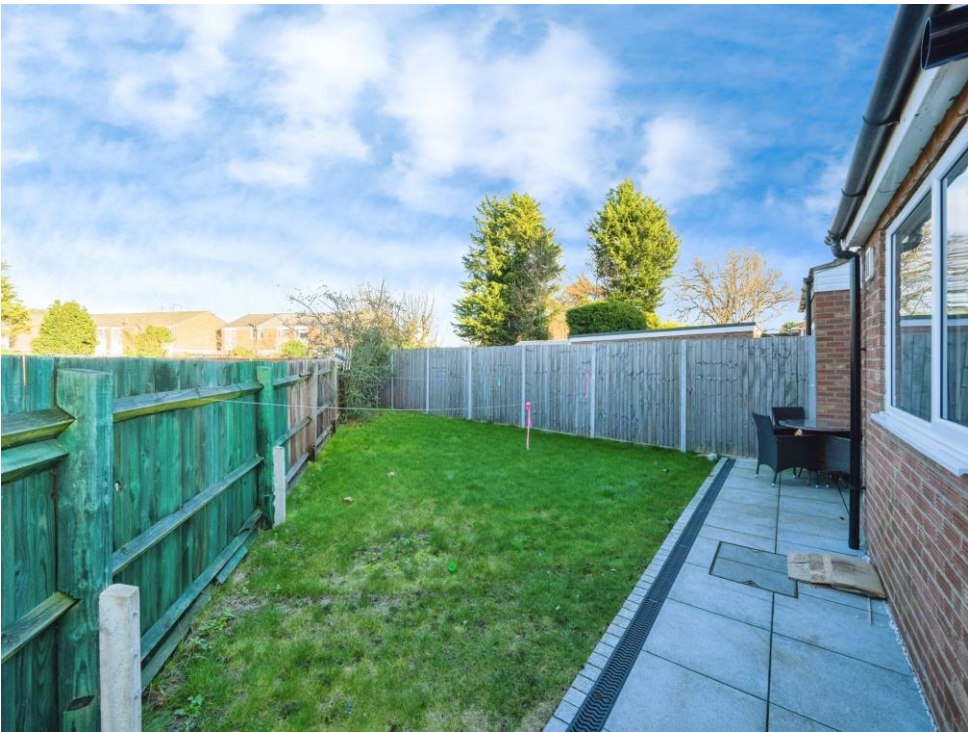

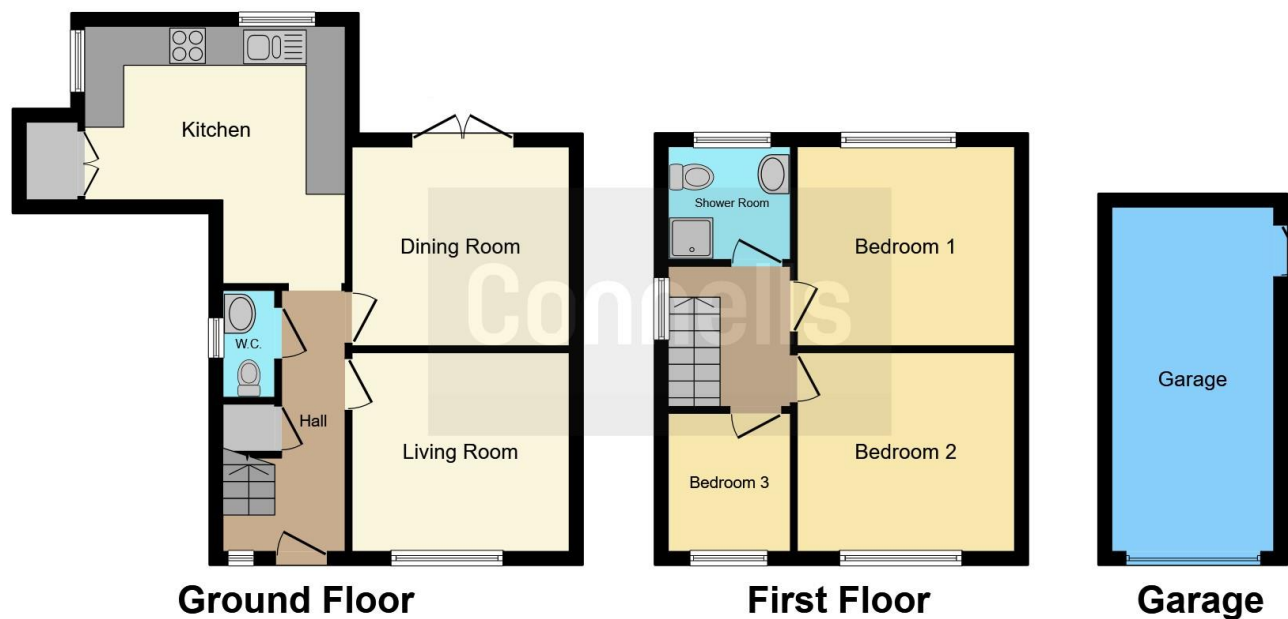
