Property Description

A light and spacious two-bedroom top floor apartment situated off Station Road. Approximately a mile from the Thameslink main line station and Harpenden High Street with secured gated parking and being offered for sale with vacant possession.

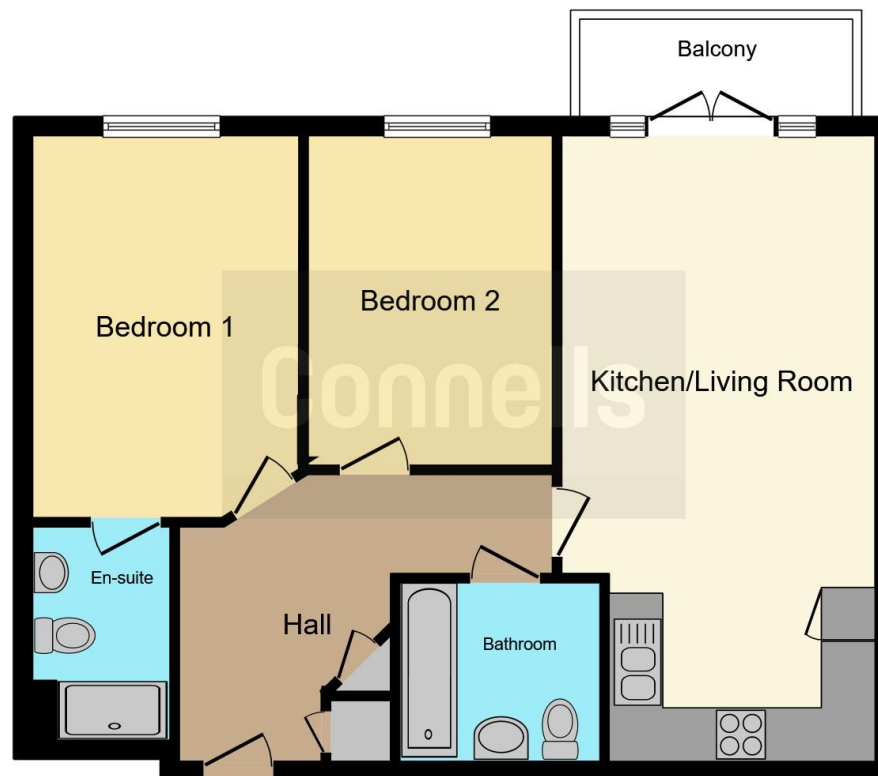
