Window to front aspect. Storage heater.

Suite comprising bath with wall mounted electric shower over, wash hand basin & low level wc.

Gardens

To the front of the block is an area of gardens belonging to the flat. Area for bin storage. At the rear of the flats is a communal area, that all the flats can use.


Garage
