## Property Description

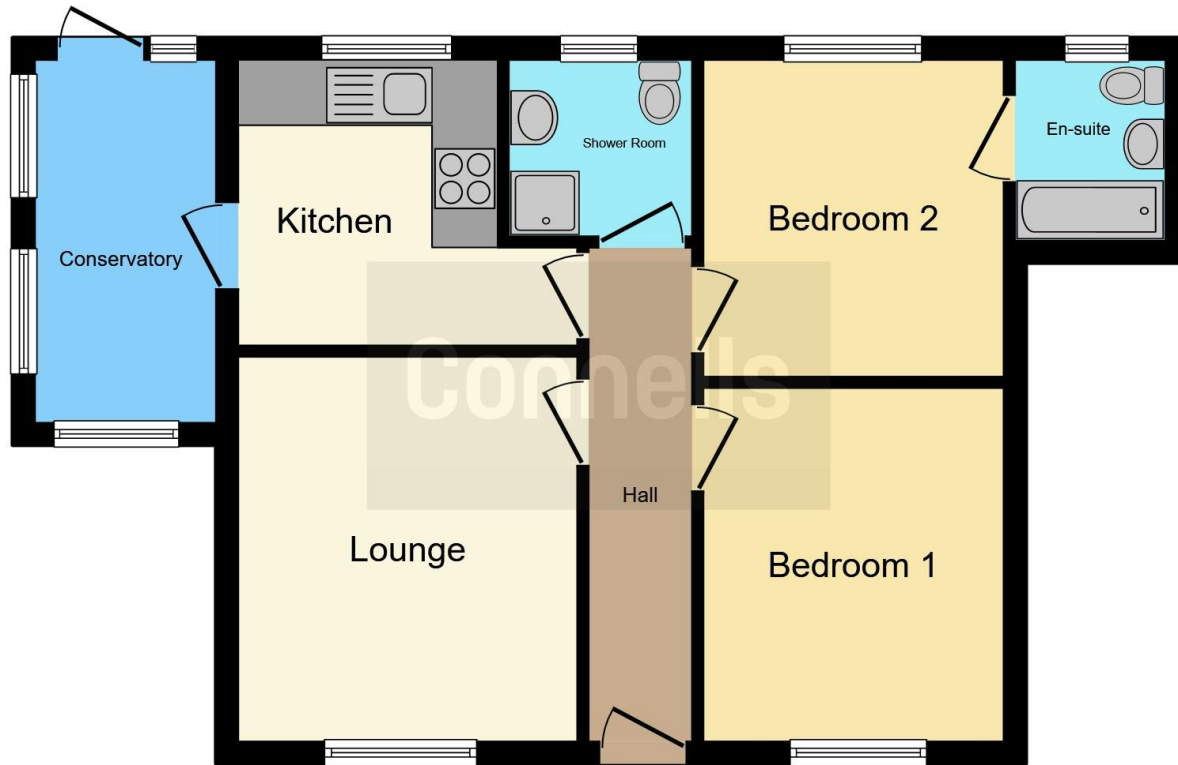
