Property Description

A two-bedroom bungalow located within close proximity to Banbury Town Centre and Banbury Train Station.

Upon entering, the hallway leads to a kitchen overlooking the front, a spacious lounge/diner with patio doors opening to the rear garden. The master bedroom is generously sized, and the second bedroom is accessible via the sun room. A walk-in wet room provides convenience and is designed with wheelchair accessibility in mind.

Externally, the property boasts a private driveway, garage, and an additional allocated parking space. The enclosed rear garden features a patio area, lawn, and side access.

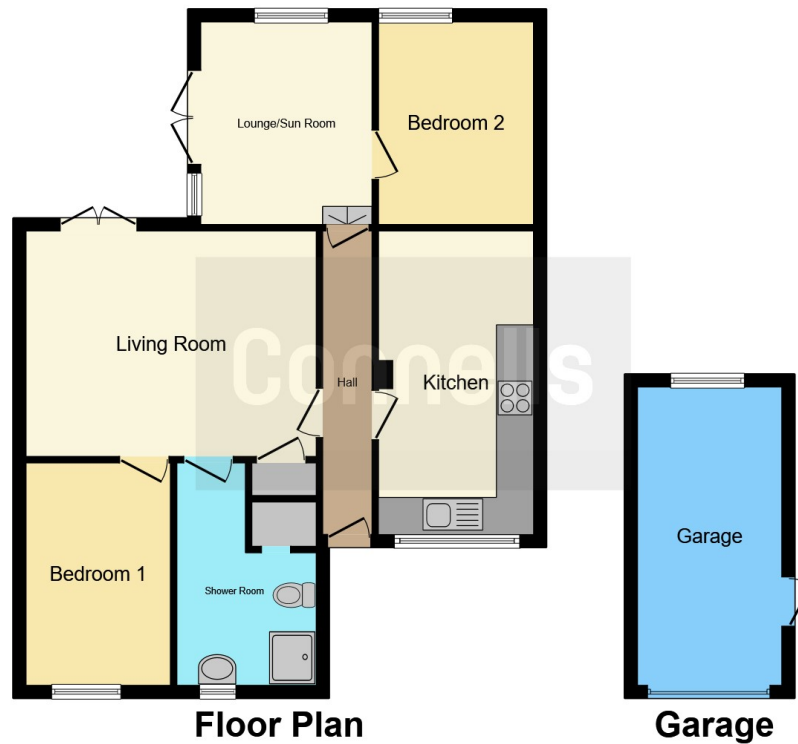
