Property Description

Well-presented three bedroom semi-detached house, with additional annex. The main house has the entrance hall which has doors that lead to the downstairs WC, open plan double aspect reception room with door leading to the rear garden. Kitchen with wall and base level units and space for white goods, door to the utility room and a further door leading to the rear garden. To the first floor are three bedrooms, two of which have fitted wardrobes, and fully tiled family bathroom with bath, shower over, WC, wash hand basin and bidet.

The annex is currently arranged as three bedrooms and a shower room, but the accommodation is flexible. To the lower ground floor there is ample storage.

Vendor has advised that there is current planning permission for a loft conversion and single storey extension to the living room.

Ideally located within walking distance of local amenities, including a main bus route that takes you in to the town centre. There are a range of primary and secondary schools in the area, including grammar schools.
